A BILL FOR AN ACT

RELATING TO RECYCLING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that the cost of
 recycling glass containers far exceeds the revenue that the
- 2 respecting graph consumers run should and revenue shad shad
- 3 State receives through the advance disposal fee, which is
- 4 imposed on sealed glass containers that are not glass deposit
- 5 beverage containers, resulting in shortfalls in payment for
- 6 glass recycling or stoppages in the recycling of glass
- 7 containers. The advance disposal fee is deposited into the
- $oldsymbol{8}$ environmental management fund, and ninety per cent is then
- ${f 9}$ disbursed to the counties to pay for recycling of glass
- 10 containers. However, the counties typically exhaust these funds
- 11 by the third quarter of a fiscal year and must then expend their
- 12 own funds for glass recycling or stop paying for glass
- 13 recycling.
- 14 The legislature further finds that there is a very limited
- 15 local market for recycled or scrap glass and that, as a result,
- 16 most of the glass is shipped to the mainland. The department of
- 17 health has determined from the reports that it receives from the

- 1 counties that it costs about 8 cents per pound to recycle glass
- 2 containers.
- 3 The legislature further finds that the advance disposal fee
- 4 of 1.5 cents per glass container has not been increased since it
- 5 was established on September 1, 1994. Also, there is a huge
- 6 disparity in weight between small glass containers and larger
- 7 glass containers, which cost more to recycle. For example, an
- 8 empty glass bottle capable of holding twelve fluid ounces
- 9 averages seven to nine ounces in weight, whereas, an empty glass
- 10 bottle capable of holding 750 milliliters, or 25.36 fluid
- 11 ounces, averages 24 ounces or 1.5 pounds in weight and an empty
- 12 glass bottle capable of holding 1.5 liters, or 50.72 fluid
- 13 ounces, typically weighs at least 60 ounces, or 3.75 pounds.
- 14 The legislature further finds that it is easier to
- 15 calculate the interior volume of glass containers, instead of
- 16 the actual weight of the glass containers.
- 17 The purpose of this Act is to revise the advance disposal
- 18 fee for glass containers to a tiered structure based on the
- 19 interior volume of the glass containers.
- 20 SECTION 2. Section 342G-82, Hawaii Revised Statutes, is
- 21 amended by amending subsection (a) to read as follows:

1	"(a) Every glass container importer shall pay to the
2	department an advance disposal fee. The fee shall be imposed
3	only once on the same glass container and shall not be assessed
4	on drinking glasses, cups, bowls, plates, ashtrays, and similar
5	tempered glass containers. For the period beginning
6	September 1, 1994, and ending December 31, 2015, the fee shall
7	be one and one-half cents per glass container. Beginning
8	October 1, 2004, the glass advance disposal fee shall only apply
9	to glass containers that are not glass deposit beverage
10	containers. Beginning January 1, 2016, the advance disposal fee
11	shall be as follows:
12	(1) 1 cent per glass container for glass containers with
13	interior volumes of less than eight fluid ounces;
14	(2) 3 cents per glass container for glass containers with
15	interior volumes of at least eight fluid ounces but
16	not more than twenty-four fluid ounces; and
17	(3) 5 cents per glass container for glass containers with
18	interior volumes greater than twenty-four fluid
19	ounces."
20	SECTION 3. The state auditor shall conduct an audit of the
21	advance disposal fee as soon as feasibly possible and five years

- 1 thereafter, the results of which shall be submitted to the
- 2 legislature.
- 3 SECTION 4. New statutory material is underscored.
- 4 SECTION 5. This Act shall take effect upon its approval.
