A BILL FOR AN ACT

RELATING TO THE OFFICE OF INFORMATION PRACTICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 92F, part IV, Hawaii Revised Statutes,
- 2 is amended by adding a new section to be appropriately
- 3 designated and to read as follows:
- 4 "§92F- Exemptions. (a) The office of information
- 5 practices shall be exempt from section 26-35(a)(1) and shall
- 6 make direct communications with the governor and legislature.
- 7 (b) The office of information practices shall follow and
- 8 be subject to all applicable personnel laws."
- 9 SECTION 2. Section 26-1, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "S26-1 Office of the lieutenant governor. (a) Except as
- 12 otherwise provided by law, the lieutenant governor is designated
- 13 the secretary of state for intergovernmental relations and shall
- 14 perform the duties and functions heretofore exercised by the
- 15 secretary of Hawaii. The duties and functions shall include,
- 16 but not be limited to, recordation of all legislative and
- 17 gubernatorial acts, certification of state documents, and
- 18 maintenance of an official file of rules adopted by state



departments as provided in chapter 91. The lieutenant governor 1 may employ staff as necessary without regard to chapter 76. 2 3 The lieutenant governor, with the approval of the governor, may designate some other officer of the government of 4 5 the State to authenticate documents on behalf of the lieutenant 6 governor during the lieutenant governor's temporary absence 7 outside the State or during the lieutenant governor's illness whenever the documents require the signature of the lieutenant 8 9 governor. The person shall affix the person's own signature to 10 the document with the words, "for the lieutenant governor" 11 following and the signature shall be deemed to satisfy the 12 requirement of the lieutenant governor's signature on the 13 document. The designation and approval shall be in writing and 14 shall be filed in the office of the governor and a copy thereof, 15 certified by the governor, shall be filed with the public 16 archives. The person so designated shall serve without additional compensation and the lieutenant governor shall be 17 18 responsible and liable on the lieutenant governor's official 19 bond for all acts done by the person so designated in the 20 performance of the duties on behalf of the lieutenant governor.

(c) Nothing in this section shall be construed to 1 2 authorize the person to exercise and discharge the powers and duties of the office of the governor as provided by the first 3 paragraph of Article V, section 4, of the Constitution of the 4 State. The person shall not be authorized to exercise any 5 powers whenever a successor to the lieutenant governor assumes 6 7 the duties of the lieutenant governor pursuant to Article V, 8 section 4, of the Constitution. 9 [(d) In addition to the functions and duties provided by 10 law, the lieutenant governor shall assume administrative 11 responsibility for the office of information practices. 12 (e) (d) The governor shall identify and direct other 13 duties as necessary to the lieutenant governor. 14 $\left[\frac{f}{f}\right]$ (e) A lieutenant governor whose legal residence is on an island other than Oahu and who is required to remain away 15 16 from the island of the lieutenant governor's legal residence but within the State overnight or longer while on official business 17 18 shall receive an allowance to cover personal expenses such as 19 board, lodging, and incidental expenses. The allowance **20** authorized under this subsection shall be set at a daily single 21 rate to be determined by a joint agreement between the senate

1	president and speaker of the house of representatives. This
2	rate shall:
3	(1) Not exceed the greater of the maximum allowance for
4	such expenses payable to any public officer or
5	employee of the State; and
6	(2) Be reasonably calculated to cover the expenses
7	specified in this subsection.
8	$[\frac{g}{g}]$ The allowance authorized under subsection $[\frac{f}{g}]$
9	(e) shall be in addition to and shall not supplant any portion
10	of the salary of the lieutenant governor determined pursuant to
11	section 26-51. The allowance shall be paid out of any available
12	appropriation made by the legislature for expenses, other than
13	the salary, of the lieutenant governor."
14	SECTION 3. Section 26-6, Hawaii Revised Statutes, is
15	amended by amending subsection (b) to read as follows:
16	"(b) The department shall:
17	(1) Preaudit and conduct after-the-fact audits of the
18	financial accounts of all state departments to
19	determine the legality of expenditures and the
20	accuracy of accounts;

1	(2)	Report to the governor and to each regular session of
2		the legislature as to the finances of each department
3		of the State;
4	(3)	Administer the state risk management program;
5	(4)	Establish and manage motor pools;
6	(5)	Manage the preservation and disposal of all records of
7		the State;
8	. (6)	Undertake the program of centralized engineering and
9		office leasing services, including operation and
10		maintenance of public buildings, for departments of
11		the State;
12	(7)	Undertake the functions of the state surveyor;
13	(8)	Establish accounting and internal control systems;
14	(9)	Provide centralized computer information management
15		and processing services, coordination in the use of
16		all information processing equipment, software,
17		facilities, and services in the executive branch of
18		the State, and consultation and support services in
19		the use of information processing and management
20		technologies to improve the efficiency, effectiveness,
21		and productivity of state government programs; [and]

1	(10)	Establish, coordinate, and manage a program to provide
2		a means for public access to public information and
3		develop and operate an information network in
4		conjunction with its overall plans for establishing a
5		communication backbone for state government[-]; and
6	(11)	Assume administrative responsibility for the office of
7		information practices."
8	SECT	ION 4. Section 28-8.3, Hawaii Revised Statutes, is
9	amended a	s follows:
10	1.	By amending subsection (a) to read:
11	"(a)	No department of the State other than the attorney
12	general m	ay employ or retain any attorney, by contract or
13	otherwise	, for the purpose of representing the State or the
14	departmen	t in any litigation, rendering legal counsel to the
15	departmen	t, or drafting legal documents for the department;
16	provided	that the foregoing provision shall not apply to the
17	employmen	t or retention of attorneys:
18	(1)	By the public utilities commission, the labor and

20		labor relations board;

2		State; provided that if the attorney general is

6	2. By amending subsection (c) to read:
7	"(c) Every attorney employed by any department on a full-
8	time basis, except an attorney employed by the public utilities
9	commission, the labor and industrial relations appeals board,
10	the Hawaii labor relations board, the office of Hawaiian
11	affairs, the Hawaii health systems corporation or its regional
12	system boards, the department of commerce and consumer affairs
13	in prosecution of consumer complaints, insurance division, the
14	division of consumer advocacy, the University of Hawaii, the
15	Hawaii tourism authority as provided in section 201B-2.5, the
16	[Hawaiian home lands trust individual claims review panel,]
17	office of information practices, or as grand jury counsel, shall
18	be a deputy attorney general."
19	SECTION 5. Section 92F-41, Hawaii Revised Statutes, is
20	amended as follows:
21	1. By amending subsection (a) to read:

"(a) There is established [a temporary] an office of 1 information practices [for a special purpose] within the [office 2 3 of the lieutenant governor] department of accounting and general services for administrative purposes." 4 5 2. By amending subsection (d) to read: "(d) The director may employ any other personnel that are 6 7 necessary, including [but not limited to] attorneys and clerical staff. All personnel of the office of information practices 8 shall be employed without regard to chapter 76." 9 SECTION 6. All rights, powers, functions, and duties of 10 11 the office of the lieutenant governor relating to the office of information practices are transferred to the department of 12 accounting and general services. 13 Employees shall be transferred without loss of salary, 14 15 seniority (except as prescribed by applicable collective bargaining agreements), retention points, prior service credit, 16 any vacation and sick leave credits previously earned, and other 17 rights, benefits, and privileges, in accordance with state 18 19 personnel laws and this Act; provided that the employees possess the minimum qualifications and public employment requirements 20 for the class or position to which transferred or appointed, as 21

- 1 applicable; provided further that subsequent changes in status
- 2 may be made pursuant to applicable civil service and
- 3 compensation laws.
- 4 Any employee who, prior to this Act, is exempt from civil
- 5 service and is transferred as a consequence of this Act may
- 6 retain the employee's exempt status, but shall not be appointed
- 7 to a civil service position as a consequence of this Act. An
- 8 exempt employee who is transferred by this Act shall not suffer
- 9 any loss of prior service credit, vacation or sick leave credits
- 10 previously earned, or other employee benefits or privileges as a
- 11 consequence of this Act; provided that the employees possess
- 12 legal and public employment requirements for the position to
- 13 which transferred or appointed, as applicable; provided further
- 14 that subsequent changes in status may be made pursuant to
- 15 applicable employment and compensation laws. The director of
- 16 the office of information practices may prescribe the duties and
- 17 qualifications of these employees and fix their salaries without
- 18 regard to chapter 76, Hawaii Revised Statutes.
- 19 SECTION 7. All appropriations, records, equipment,
- 20 machines, files, supplies, contracts, books, papers, documents,
- 21 maps, and other personal property heretofore made, used,

- 1 acquired, or held by the office of the lieutenant governor
- 2 relating to the functions transferred to the department of
- 3 accounting and general services shall be transferred with the
- 4 functions to which they relate.
- 5 SECTION 8. All rules, policies, procedures, guidelines,
- 6 and other material adopted or developed by the office of
- 7 information practices to implement provisions of the Hawaii
- 8 Revised Statutes which are reenacted or made applicable to the
- 9 department of accounting and general services by this Act, shall
- 10 remain in full force and effect until amended or repealed by the
- 11 office of information practices pursuant to chapter 91, Hawaii
- 12 Revised Statutes. In the interim, every reference to the office
- 13 of the lieutenant governor or the lieutenant governor in those
- 14 rules, policies, procedures, guidelines, and other material is
- 15 amended to refer to the department of accounting and general
- 16 services or the comptroller as appropriate.
- 17 SECTION 9. All deeds, leases, contracts, loans,
- 18 agreements, permits, or other documents executed or entered into
- 19 by or on behalf of the office of information practices pursuant
- 20 to the provisions of the Hawaii Revised Statutes, which are
- 21 reenacted or made applicable to the department of accounting and

- 1 general services by this Act, shall remain in full force and
- 2 effect. Upon the effective date of this Act, every reference to
- 3 the office of the lieutenant governor or the lieutenant governor
- 4 therein shall be construed as a reference to the department of
- 5 accounting and general services or the comptroller as
- 6 appropriate.
- 7 SECTION 10. There is appropriated out of the general
- 8 revenues of the State of Hawaii the sum of \$ or so
- 9 much thereof as may be necessary for fiscal year 2015-2016 and
- 10 the same sum or so much thereof as may be necessary for fiscal
- 11 year 2016-2017 to fund one full-time equivalent account clerk V
- 12 position (1.0 FTE) and one full-time equivalent personnel clerk
- 13 V position (1.0 FTE) to provide administrative support for the
- 14 office of information practices and the other administratively
- 15 attached agencies.
- 16 The sums appropriated shall be expended by the department
- 17 of accounting and general services for the purposes of this Act.
- 18 SECTION 11. Statutory material to be repealed is bracketed
- 19 and stricken. New statutory material is underscored.
- 20 SECTION 12. This Act shall take effect on January 7, 2059;
- 21 provided that:

- (1) Sections 1, 2, 3, 5, 6, 7, 8, and 9 shall take effect
 on July 1, 2016; and
- 3 (2) Section 10 shall take effect on July 1, 2015.
