A BILL FOR AN ACT

RELATING TO PERSONS WITH DISABILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that Act 200, Session
2	Laws of Hawaii 2012, established a joint legislative task force
3	to explore the possibility of implementing a medicaid buy-in
4	program for individuals with disabilities who are either not
5	working or currently working and would like to earn more income,
6	based upon Hawaii's current medicaid income and asset limits,
7	subject to approval of the federal Centers for Medicare and
8	Medicaid Services. The legislature notes that a significant
9	portion of the population in Hawaii receives federal or state
10	benefits because of disabling conditions. Moreover, current
11	state programs and policies, including state-designed medicaid
12	waiver programs, create disincentives for persons with
13	disabilities to become employed, maintain employment, or
14	increase their employment income.
15	The legislature also finds that from 2005 through 2012,
16	Hawaii was the recipient of a grant from the federal Centers for
17	Medicare and Medicaid Services for the development of a medicaid
18	infrastructure program to design and implement a medicaid buy-in

- program for individuals with disabilities who are employed or
 desire to become employed and purchase medicaid coverage
- 3 authorized under the Ticket to Work and Work Incentives
- 4 Improvement Act of 1999 (P.L. 106-170). Prior to 1999, other
- 5 potential federal options for the creation of a medicaid buy-in
- 6 program included the 1997 Balanced Budget Act and a waiver
- 7 pursuant to title 42 United States Code section 1115, the Social
- 8 Security Act.
- 9 The legislature further finds that it is advantageous for
- 10 economic development in the State and in the best interests of
- 11 Hawaii's citizens with disabilities to establish programs and
- 12 policies that encourage employment. It is the intent of the
- 13 legislature that all state agencies work with citizens to
- 14 identify and remove barriers to employment for persons with
- 15 disabilities. Adults with disabilities need adequate health
- 16 insurance, but options for insurance coverage are limited, even
- 17 with the federal Patient Protection and Affordable Care Act.
- 18 The purpose of this Act is to encourage individuals with
- 19 disabilities to gain employment and improve their employment
- 20 opportunities by expanding medicaid eligibility for workers with
- 21 disabilities.

- 1 SECTION 2. Chapter 346, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated and to read as follows: 3 4 Working disabled adults eligibility group. (a) "§346-5 There is established within the department a new medicaid 6 eligibility group for workers with disabilities. The purpose of 7 the medicaid disabled adults eligibility group is to support 8 employment of individuals with disabilities by expanding their 9 access to medicaid. 10 (b) Criteria for the medicaid working disabled adults 11 eligibility group shall include: 12 (1) Be a resident of the State; 13 (2) Be at least nineteen years of age but less than sixty-14 five years of age; (3) Meet medicaid citizenship requirements; 15 Have a disability, as defined by the Social Security 16 (4)17 Administration; and 18 (5) Not be eligible for any other medicaid eligibility. The department shall use the same eligibility criteria 19 (C) 20 for the working disabled adults eligibility group as for 21 eligibility in the medicaid aged, blind, and disabled group, 22 except that the department shall:

1	(1)	Disregard earned income in an amount determined by the	
2		department, but not less than \$1,000 per month; and	
3	(2)	Have an asset limit as determined by the department,	
4		but not less than the asset limit for the medicaid	
5		aged, blind, and disabled group.	
6	(d)	The department shall adopt rules pursuant to chapter	
7	91 necess	ary for the purposes of this section."	
8	SECT	ION 3. The department of human services shall	
9	implement	the working disabled adults eligibility group no later	
10	than July	1, 2015.	
11	SECT	ION 4. There is appropriated out of the general	
12	revenues	of the State of Hawaii the sum of \$ or so	
13	much thereof as may be necessary for fiscal year 2015-2016 and		
14	the same sum or so much thereof as may be necessary for fiscal		
15	year 2016-2017 for the working disabled adults eligibility group		
16	to suppor	t employment of individuals with disabilities by	
17	expanding	their access to medicaid.	
18	The	sums appropriated shall be expended by the department	
19	of human	services for the purposes of this Act.	
20	SECT	ION 5. New statutory material is underscored.
