A BILL FOR AN ACT

RELATING TO A LAW ENFORCEMENT STANDARDS BOARD.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. It is the role of the State to oversee and
- 2 regulate professions and occupations that have a significant
- 3 impact on society. Law enforcement is an area where more should
- 4 be done by the State to provide standards and uniformity
- 5 statewide, as the State did recently through a law to regulate
- 6 private security guards.
- 7 Given the immense authority that the State and counties
- 8 grant to police, sheriffs, and other law enforcement officers,
- 9 including the power to search, arrest, and use deadly force, the
- 10 State must enact a law that certifies law enforcement officers
- 11 to ensure the highest standards of professionalism and
- 12 uniformity of standards throughout our islands.
- Hawaii is the only state in the country without any state-
- 14 level regulation of police. Regulation is left to the counties.
- 15 Furthermore, Hawaii does not have any procedure for revoking a
- 16 police officer's certification for serious misconduct.
- 17 The purpose of this Act is to establish a law enforcement
- 18 standards board for the certification of county police officers,



state public safety officers employed by the department of 1 2 public safety, and employees at the departments of 3 transportation and land and natural resources with police 4 powers. 5 The Hawaii Revised Statutes is amended by SECTION 2. 6 adding a new chapter to be appropriately designated and to read 7 as follows: 8 "CHAPTER 9 LAW ENFORCEMENT STANDARDS BOARD 10 -1 Definitions. As used in this chapter, unless the context clearly indicates otherwise, the following terms shall 11 mean as follows: 12 "Board" means the law enforcement standards board. 13 14 "Candidate" means an individual seeking certification as a 15 law enforcement officer. "Law enforcement officer" means: 16 17 (1) A police officer employed by a county police 18 department; (2) A public safety officer employed by the department of 19

public safety; or

19		the governor, in accordance with section 26-34; and

3	(d)	The terms of the members shall be four years, and no
4	person sh	all be appointed consecutively to more than two terms;
5	provided	that membership on the board shall not exceed eight
6	consecutive years, in accordance with section 26-34.	
7	(C)	Six members of the board shall constitute a quorum,
8	and a quo	rum may exercise all the power and authority conferred
9	on the board.

19		standards for employment and, in so doing, may
20		subpoena persons, books, records, or documents related

1		to the investigation and require answers in writing
2		under oath;
3	(7)	Establish and require participation in continuing
4		education programs for law enforcement officers;
5	(8)	Charge and collect fees from candidates seeking
6		certification as a law enforcement officer; and
7	(9)	Investigate any allegations of wrongdoing, misconduct,
8		or questionable operations involving any state or
9		county law enforcement agency or law enforcement
10		officer and, in so doing, may subpoena persons, books,
11		records, or documents related to the investigation and
12		require answers in writing under oath. Any findings
13		and information may be shared with the appropriate
14		county or state commission, board, or agency.
15	5	-4 Law enforcement standards board special fund;
16	establish	ed. There is established in the state treasury the law
17	enforceme	nt standards board special fund. The revenues of the
18	special f	und shall consist of appropriations made by the
19	legislatu	re, fees charged by the board, grants, gifts, and
20	interest	on moneys deposited in the special fund. The special

- 1 fund shall be used to defray the expenses of the board in
- 2 implementing this chapter.
- 3 § -5 Training. (a) The board may establish law
- 4 enforcement training programs through agencies and institutions
- 5 deemed appropriate by the board to certify candidates; provided
- 6 that the board shall establish minimum training requirements for
- 7 law enforcement officers.
- 8 (b) Each government agency or department shall be
- 9 responsible for training its staff to meet the necessary
- 10 standards or qualifications.
- 11 § -6 Standards. (a) No person may be appointed or
- 12 hired as a law enforcement officer unless the person:
- 13 (1) Has satisfactorily completed a basic program of law
- enforcement training approved by the board; and
- 15 (2) Possesses other qualifications that the board has
- 16 established for the employment of law enforcement
- officers, including minimum age, education, physical
- and mental standards, citizenship, good conduct, moral
- 19 character, and experience.
- 20 (b) The board shall issue a certificate evidencing
- 21 satisfaction of the requirements of this section to a candidate

- 1 who satisfies the requirements of subsection (a) or
- 2 satisfactorily completes a program or course of instruction in
- 3 another jurisdiction equivalent in content and quality to that
- 4 required under subsection (a).
- 5 (c) The board may deny or revoke the certificate of a
- 6 candidate or law enforcement officer who fails to meet or
- 7 maintain the standards required under subsection (a), subject to
- 8 due process.
- 9 (d) The board may deny or revoke the certificate of a
- 10 candidate or law enforcement officer who has been involved in an
- 11 act of criminal misconduct, subject to due process.
- 12 § -7 Employment of law enforcement officers. (a)
- 13 Except as provided under subsection (b), beginning on January 1,
- 14 2018, no person shall be appointed or hired as a law enforcement
- 15 officer by any county police department, the department of
- 16 public safety, the department of transportation, or the
- 17 department of land and natural resources, unless the person has
- 18 a valid certificate issued by the board under section -6.
- 19 Law enforcement officers under contract by the State shall meet
- 20 the minimum qualifications established by the board.

- 1 (b) This section shall not apply to a person employed on a
- 2 probationary basis, except that employment on a probationary
- 3 basis may not exceed the period authorized for probationary
- 4 employment as determined by the board.
- 5 (c) Beginning December 31, 2018, existing law enforcement
- 6 officers shall have two years to obtain a valid certificate
- 7 issued by the board under section -6. In-service training
- 8 shall be used to meet the law enforcement training requirements
- 9 established under section -6."
- 10 SECTION 3. There is appropriated out of the general
- 11 revenues of the State of Hawaii the sum of \$ or so
- 12 much thereof as may be necessary for fiscal year 2015-2016 and
- 13 the same sum or so much thereof as may be necessary for fiscal
- 14 year 2016-2017 for deposit into the law enforcement standards
- 15 board special fund.
- 16 SECTION 4. There is appropriated out of the law
- 17 enforcement standards board special fund the sum of \$
- 18 or so much thereof as may be necessary for fiscal year 2015-2016
- 19 and the same sum or so much thereof as may be necessary for
- 20 fiscal year 2016-2017 for the purposes of this Act.

- 1 The sums appropriated shall be expended by the department
- 2 of the attorney general for the purposes of this Act.
- 3 SECTION 5. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were
- 5 begun before its effective date.
- 6 SECTION 6. This Act shall take effect on July 1, 2015.

Establishes a law enforcement standards board for the certification of county police officers, state public safety officers, and employees of the departments of transportation and land and natural resources with police powers. Beginning on 1/1/2018, prohibits appointment or hiring of these officers unless certified by the law enforcement standards board. Establishes a special fund. (SD1)
