A BILL FOR AN ACT

RELATING TO COLLECTIVE BARGAINING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The purpose of this Act is to allow graduate
- 2 students employed by the University of Hawaii to collectively
- 3 bargain.
- 4 SECTION 2. Section 89-6, Hawaii Revised Statutes, is
- 5 amended by amending subsection (f) to read as follows:
- 6 "(f) The following individuals shall not be included in
- 7 any appropriate bargaining unit or be entitled to coverage under
- 8 this chapter:
- 9 (1) Elected or appointed official;
- 10 (2) Member of any board or commission; provided that
- 11 nothing in this paragraph shall prohibit a member of a
- 12 collective bargaining unit from serving on a governing
- 13 board of a charter school, on the state public charter
- 14 school commission, or as a charter school authorizer
- established under chapter 302D;
- 16 (3) Top-level managerial and administrative personnel,
- including the department head, deputy or assistant to
