A BILL FOR AN ACT

RELATING TO LOBBYISTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. To preserve public confidence in public
- 2 servants and ensure the highest standards of ethical conduct,
- 3 the state constitution mandates that elected officers and public
- 4 employees subscribe to a strict code of ethics. In promoting
- 5 high standards of ethical conduct, the state code of ethics
- 6 prohibits legislators and public employees from receiving gifts
- 7 that can be reasonably inferred to be intended to influence a
- 8 legislator's or public employee's performance of duties or
- 9 intended as a reward for any official action on the legislator's
- 10 or employee's part.
- 11 Although legislators and public employees are prohibited
- 12 from receiving gifts that may appear to influence their actions,
- 13 lobbyists are not likewise prohibited from giving gifts to
- 14 legislators and public employees that are intended to influence
- 15 legislators' and public employees' official actions.
- The purpose of this Act is to prohibit lobbyists from
- 17 giving gifts to officials in the legislative or executive branch

- 3 the state ethics commission to assess an administrative fine for

- 5 SECTION 2. Section 97-5, Hawaii Revised Statutes, is
- 6 amended to read as follows:
- 7 "[+]§97-5[+] Restricted activities. (a) No lobbyist
- 8 shall accept or agree to accept any payment in any way
- 9 contingent upon the defeat, enactment, or outcome of any
- 10 proposed legislative or administrative action.
- 11 (b) No lobbyist shall give, convey, or subsidize, directly
- 12 or indirectly, any gift to an elected official in the
- 13 legislature or an employee in the executive branch, whether in
- 14 the form of money, service, loan, travel, entertainment,
- 15 hospitality, thing, or promise, or in any other form, under
- 16 circumstances in which it can reasonably be inferred that the
- 17 gift is intended to influence the legislator or employee in the
- 18 performance of the legislator's or employee's official duties or
- 19 intended as a reward for any official action on the legislator's
- 20 or employee's part. The state ethics commission may assess an

- 1 administrative fine of no more than \$ for a violation
- 2 of this subsection."
- 3 SECTION 3. This Act does not affect rights and duties that
- 4 matured, penalties that were incurred, and proceedings that were
- 5 begun before its effective date.
- 6 SECTION 4. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 5. This Act shall take effect upon its approval.
