A BILL FOR AN ACT

RELATING TO ANIMAL TRANSPORT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 142, Hawaii Revised Statutes, is
- 2 amended by adding two new sections to be appropriately
- 3 designated and to read as follows:
- 4 "§142- Transport of animals by air. (a) No person
- 5 shall transport an animal by air to, from, or within the State,
- 6 except in compliance with this section and the live animals
- 7 regulations established by the International Air Transport
- 8 Association.
- 9 (b) Food and water shall be given to coldblooded animals
- 10 within eight hours of delivery to the carrier and to warmblooded
- 11 animals within two hours of delivery to the carrier, unless
- 12 otherwise required by law or specified by International Air
- 13 Transport Association regulations.
- 14 (c) A feeding or watering certification shall be completed
- 15 in duplicate documenting the date and time of last feeding and
- 16 confirming compliance with subsection (b). One copy of the
- 17 certification shall be attached to the top of the animal
- 18 container and the other copy to the air waybill.
