#### A BILL FOR AN ACT

RELATING TO SPINNER DOLPHINS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the expansion of
- 2 recreational activities in the ocean has resulted in continuous
- 3 harassment of Hawaii's spinner dolphins. Spinner dolphins have
- 4 a rigid daily schedule: hunting in the ocean at night and
- 5 resting in shallow bays close to the shore during the day.
- 6 Human activities frequently disrupt their rest periods and
- 7 endanger the population. It is important to respect spinner
- 8 dolphins' need for space in order to safeguard the species for
- 9 future generations to appreciate.
- 10 The legislature recognizes the valuable contributions these
- 11 animals make to the marine ecosystem and the tourism industry
- 12 and finds that limiting human interaction with spinner dolphins
- 13 will help protect their current population.
- 14 The purpose of this Act is to protect Hawaii's small
- 15 population of spinner dolphins so that visitors and locals can
- 16 continue to enjoy the aerial acrobatics of these marine mammals

- 3 SECTION 2. Chapter 187A, Hawaii Revised Statutes, is
- 4 amended by adding a new section to be appropriately designated
- 5 and to read as follows:
- 6 "§187A- Taking a spinner dolphin prohibited. (a) A
- 7 person commits the offense of taking a spinner dolphin if the
- 8 person intentionally or knowingly takes a spinner dolphin
- 9 (Stenella longirostris).
- 10 (b) Any person convicted of taking a spinner dolphin shall
- 11 be quilty of a class C felony; provided that in addition to any
- 12 other sentence, the court may impose a fine up to \$50,000.
- (c) For the purpose of this section:
- "Take" means to touch, ride, harass, harm, pursue, hunt,
- 15 shoot, wound, kill, trap, capture, collect, or to attempt to
- 16 engage in any such conduct."
- 17 SECTION 3. This Act does not affect rights and duties that
- 18 matured, penalties that were incurred, and proceedings that were
- 19 begun before its effective date.
- 20 SECTION 4. New statutory material is underscored.
