A BILL FOR AN ACT

RELATING TO HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 201H, Hawaii Revised Statutes, is		
2	amended by adding a new section to be appropriately designated		
3	and to read as follows:		
4	"§201H- Community land trust. (a) The corporation may		
5	establish a community land trust for the purpose of selling		
6	homes to low- and moderate-income homebuyers.		
7	(b) The community land trust may hold title to land and		
8	lease land to members of low- or moderate-income households;		
9	provided that:		
10	(1) The lease shall be designed to preserve long-term		
11	affordable housing on the land;		
12	(2) The terms of the lease shall give the community land		
13	trust the first option to purchase any structural		
14	improvement placed on the land; and		
15	(3) The lease may have an initial term of not more than		
16	ninety-nine years.		
17	(c) The community land trust shall be a member-based		
18	organization and reserve core mission decisions for the members.		

1	<u>(d)</u>	The community land trust may:
2	(1)	Adopt, amend, and repeal bylaws governing the conduct
3		of its business;
4	(2)	Execute, in accordance with its bylaws, all
5		instruments necessary or appropriate in the exercise
6		of its powers;
7	(3)	Acquire property for future development pursuant to
8		this section;
9	(4)	Buy and sell homes and related structures pursuant to
10		this section; and
11	(5)	Receive moneys from donations, membership fees, the
12		State, the counties, or the federal government.
13	(e)	For purposes of this section, "community land trust"
14	means a n	onprofit organization that:
15	(1)	Acquires parcels of land, held in perpetuity,
16		primarily for conveyance under long-term ground
17		<pre>leases;</pre>
18	(2)	Transfers ownership of any structural improvements
19		located on leased parcels to the lessees;

1	<u>(3)</u>	Has its corporate membership open to any adult
2		resident of a particular geographic area specified in
3		the organization's bylaws;
4	(4)	Retains a first option to purchase any structural
5		improvement at a price determined by formula that is
6		designed to ensure that the improvement remains
7		affordable to low- and moderate-income households; and
8	<u>(5)</u>	Is governed by a board of directors that:
9		(A) Includes a majority of members who are elected by
10		the corporate membership; and
11		(B) Is composed of equal numbers of lessees,
12		corporate members who are not lessees, and any
13		other category of persons described in the bylaws
14		of the organization."
15	SECT	ION 2. New statutory material is underscored.
16	SECT:	ION 3. This Act shall take effect upon its approval.
