A BILL FOR AN ACT

RELATING TO CYBERSECURITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the economic
- 2 viability of Hawaii rests upon the State's ability to monitor,
- 3 detect, and defend its critical infrastructure from cyber-
- 4 attacks. The quantity and sophistication of cyber events, as
- 5 well as the variety of attacks, will continue to evolve and grow
- 6 exponentially in the years to come. Implementing effective
- 7 cybersecurity measures will also be a constantly evolving
- 8 challenge. Therefore, it is of critical importance for the
- 9 State to establish a full-time Hawaii cybersecurity, economic,
- 10 education, and infrastructure security coordinator to
- 11 continuously assess and synchronize all efforts within the State
- 12 to properly and robustly develop and prioritize the resources
- 13 necessary to build the cybersecurity wherewithal of the State.
- 14 The purpose of this Act is to strengthen Hawaii's
- 15 cybersecurity by:

2		the Hawaii cybersecurity, economic, education, and
3		infrastructure security coordinator;
4	(2)	Providing the coordinator with a secretary; and
5	(3)	Appropriating funds for the coordinator and secretary
6		positions.
7	SECTION 2. Section 128B-1, Hawaii Revised Statutes, is	
8	amended b	y amending subsection (a) to read as follows:
9	"(a)	There is established, without regard to chapter 76,
10	the full-time Hawaii cybersecurity, economic, education, and	
11	infrastructure security coordinator to oversee cybersecurity and	
12	cyber resiliency matters, including cybersecurity, economic,	
13	education, and infrastructure security for the State. The	
14	coordinator may employ, without regard to chapter 76, one	
15	secretary who shall generally assist the coordinator. The	
16	coordinator shall be placed within the state department of	
17	defense."	
18	SECT	ION 3. There is appropriated out of the general
19	revenues	of the State of Hawaii the sum of \$ or so
20	much thereof as may be necessary for fiscal year 2015-2016 and	
21	the same sum or so much thereof as may be necessary for fiscal

- year 2016-2017 for the Hawaii cybersecurity, economic, 1

- The sums appropriated shall be expended by the department 4
- of defense for the purposes of this Act. 5
- 6 SECTION 4. Statutory material to be repealed is bracketed
- and stricken. New statutory material is underscored. 7
- SECTION 5. This Act shall take effect on July 1, 2015. 8
