A BILL FOR AN ACT

RELATING TO THE COLORECTAL CANCER SCREENING AND AWARENESS PILOT PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that of cancers affecting
- 2 men and women, cancer of the colon and rectum, also known as
- 3 colorectal cancer, is the second-leading cause of cancer-related
- 4 deaths in the United States. In 2011, the United States Centers
- 5 for Disease Control and Prevention reported that 135,260 people
- 6 in the United States were diagnosed with colorectal cancer,
- 7 including 70,099 men and 65,161 women. That same year, 51,783
- 8 people in the United States died from colorectal cancer,
- 9 including 26,804 men and 24,979 women. According to the
- 10 National Cancer Institute, in 2014, it is estimated that there
- 11 were 136,830 new cases of colorectal cancer diagnosed in the
- 12 United States and 50,310 deaths due to the disease.
- 13 The legislature further finds that cancer is the second-
- 14 leading cause of death in Hawaii. Each year, almost 6,000
- 15 people throughout the State are diagnosed with cancer, and more
- 16 than 2,000 die from the disease. According to the Hawaii Tumor

- 1 Registry of the Cancer Research Center of Hawaii, colorectal
- 2 cancer is the third-most diagnosed form of cancer in men and the
- 3 second-most diagnosed form of cancer in women in the State.
- 4 Colorectal cancer is also the second-leading cause of cancer-
- 5 related deaths among men and the third-leading cause of cancer-
- 6 related death among women in the State.
- 7 The legislature additionally finds that because colorectal
- 8 cancer almost always develops from precancerous polyps in the
- 9 colon or rectum, screening tests are an easy and effective
- 10 method to find precancerous polyps and detect colorectal cancer
- 11 in its early stages.
- 12 The legislature also finds that a screening program will
- 13 increase detections of any cancer at an early stage, improving
- 14 chances for survival and decreasing mortality rates. With the
- 15 success of the Hawaii comprehensive breast and cervical cancer
- 16 control program, established by the legislature in 1997 to
- 17 provide breast and cervical cancer screening, the legislature
- 18 finds that this program is a model of an effective approach to
- 19 increasing the number of screenings and early detection of
- 20 colorectal cancer.
- 21 The purpose of this Act is to:



1	(1)	Establish a two-year Hawaii colorectal cancer
2		screening and awareness pilot program, using the
3		Hawaii comprehensive breast and cervical cancer
4		control program as a model; and
5	(2)	Appropriate funds for the pilot program.
6	SECT	ION 2. (a) There is established the Hawaii colorecta
7	cancer sc	reening and awareness pilot program, to be administered
8	by the de	partment of health, to facilitate the early detection
9	of colore	ctal cancer and assist individuals who have been
10	diagnosed	with colorectal cancer.
11	(b)	Under the Hawaii colorectal cancer screening and
12	awareness	pilot program, the department of health shall:
13	(1)	Educate, train, and improve the skills of health care
14		professionals, including allied health professionals
15		and lay health educators, in the detection and
16		management of colorectal cancer;
17	(2)	Educate women and men regarding the risks associated
18		with colorectal cancer and the benefits of screening;
19	(3)	Provide outreach to individuals who are at greater
20		risk for colorectal cancer; and

- (4) Provide referral services for individuals diagnosed
 with colorectal cancer.
- 3 (c) The department of health shall submit a report to the
- 4 legislature no later than twenty days prior to the convening of
- 5 the 2016 and 2017 regular sessions on the expenditure of all
- 6 funds for the Hawaii colorectal cancer screening and awareness
- 7 pilot program.
- 8 SECTION 3. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$200,000 or so much
- 10 thereof as may be necessary for fiscal year 2015-2016 and the
- 11 same sum or so much thereof as may be necessary for fiscal year
- 12 2016-2017 for the Hawaii colorectal cancer screening and
- 13 awareness pilot program.
- 14 The sums appropriated shall be expended by the department
- 15 of health for the purposes of this Act.
- 16 SECTION 4. This Act shall take effect on July 1, 2015, and
- 17 shall be repealed on June 30, 2017.
