#### A BILL FOR AN ACT

RELATING TO VETERINARY TECHNICIANS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Veterinary technicians are key members of the 2 veterinary health care team, second only to the licensed 3 veterinarians, in delivering quality animal care to the 4 community. In public service, veterinary technicians ensure 5 compliance with animal care and control at the University of Hawaii and at the department of agriculture in the animal 6 7 industry division, in laboratories, and in the rabies quarantine branch. Veterinary technicians assist veterinarians at the 8 Honolulu Zoo to promote and ensure animal health. Veterinary 9 technicians also play key roles in the shelter and rescue 10 11 community. In private practice, supervised by licensed 12 veterinarians, veterinary technicians assist in managing the 13 practice and the veterinary health care team. By their superior training, they assist the veterinarian in educating the staff 14 15 and public and provide hands-on quality veterinary medical and surgical services. 16

1	While students must travel to the continental United States					
2	if seeking a doctorate of veterinary medicine, Hawaii has a					
3	successful, accredited veterinary technician program at Windward					
4	community college. Entering its second year, the program enjoys					
5	ongoing popularity and outstanding success, and its graduates					
6	are easily placed in employment positions.					
7	Currently, the State of Hawaii is the last to recognize					
8	veterinary technicians as bona fide health professionals.					
9	Veterinary technicians should be registered in Hawaii to ensure					
10	the continuing delivery of quality veterinary service to the					
11	community and to protect animal welfare.					
12	The purpose of this Act is to improve the level of care of					
13	animals in the State by:					
14	(1) Establishing requirements for the regulation of					
15	veterinary technicians and the practice of veterinary					
16	technology under chapter 471, Hawaii Revised Statutes,					
17	relating to veterinary medicine;					
18	(2) Establishing provisions relating to registration					
19	requirements, educational requirements, limitations on					
20	use of titles, grounds for refusal to grant and

1	revocation or suspension of registration, hearings,			
2	and criminal penalties; and			
3	(3) Requiring the board of veterinary examiners to issue			
4	certificates of registration to applicants beginning			
5	on July 1, 2017.			
6	SECTION 2. Chapter 471, Hawaii Revised Statutes, is			
7	amended by adding a new section to be appropriately designated			
8	and to read as follows:			
9	<pre>"§471- Veterinary technicians; registrations; renewals;</pre>			
10	continuing education. (a) Except as otherwise provided in this			
11	chapter, beginning July 1, 2017, the board shall issue a			
12	certificate of registration to engage in the practice of			
13	veterinary technology as a veterinary technician to all			
14	applicants who meet the requirements of this chapter, upon			
15	payment of all applicable fees.			
16	(b) All registrations issued by the board shall expire on			
17	June 30 of each even-numbered year. Failure to renew the			
18	registration on or before June 30 of each even-numbered year			
19	shall automatically constitute a forfeiture of the registration;			
20	provided that the registration shall be restored upon the			
21	submission of a written application, payment of all applicable

1	fees, and proof of completing the applicable continuing
2	education credits to the board.
3	(c) Prior to June 30, 2020, and prior to every
4	registration renewal thereafter, a registrant shall meet the
5	following requirements in order to renew a veterinary technician

8	(2) Meet the requirements of this chapter; and
9	(3) Complete at least twenty credit hours of continuing
10	education within the two-year period preceding the
11	renewal date.
12	(d) A registrant who has graduated from an accredited
13	veterinary technician program within one year of the
14	registrant's first registration renewal shall not be subject to
15	the continuing education requirement for the first registration
16	renewal.
17	(e) Each registrant shall be responsible for maintaining
18	the registrant's continuing education records. At the time of
19	renewal, each registrant shall certify under oath that the
20	registrant has complied with the continuing education
21	requirement of this section. The board may require a registrant

2	satisfactory to the board that demonstrates compliance with the

4	(f) The board may conduct random audits of registrants to
5	determine compliance with the continuing education requirement.
6	The board shall provide written notice of an audit to a
7	registrant randomly selected for audit. Within sixty days of
8	notification, the registrant shall provide the board with
9	documentation verifying compliance with the continuing education
10	requirement established by this section.
11	(g) Notwithstanding any other provision, no registration
12	shall expire while the registrant is serving on active duty in
13	the armed forces of the United States during any emergency
14	declared by the President or Congress and six months after the
15	termination thereof."
16	SECTION 3. Section 471-1, Hawaii Revised Statutes, is
17	amended by adding five new definitions to be appropriately
18	inserted and to read as follows:
19	" <u>"Direct supervision</u> " means a licensed veterinarian is
20	physically present at the location where animal health care
21	tasks are to be performed.

2	physically present at a location, but has given direct orders in

4	animal an	d the animal has been examined by the veterinarian.

3 "§471-8 Examinations; qualifications of applicants. (a) 4 No person shall be licensed to practice veterinary medicine 5 unless the person has passed an examination of the qualifications and fitness to engage in the practice of 6 veterinary medicine given by the board of veterinary examiners. 7 Before any applicant shall be eligible for examination under 8 this chapter the applicant, at least sixty days before the date 9 set for examination, shall file an application in the form as 10 shall be prescribed by the board, pay to the department of 11 12 commerce and consumer affairs application and examination fees, and furnish proof satisfactory to the board that the applicant: 13 Is eighteen or more years of age; and 14 (1)Is a graduate of a veterinary college meeting all the 15 (2)standards established by the American Veterinary 16 Medical Association, or, in lieu thereof, has actively 17 practiced for ten out of twelve years immediately 18 19 preceding the date of application in a state having 20 standards for licensing comparable to those in this 21 State.

1 (b) Examinations shall be given by the board twice each 2 year except when there are no applications pending. They shall be composed of written questions, a part of which shall consist 3 of those aspects of veterinary medicine common to the State on 4 5 toxic substances, parasite diseases, unique soil conditions, and 6 quarantine standards. The same questions shall be given to each 7 person being examined during a particular examination. The subject matter of the examinations shall embrace the subjects 8 9 and demonstrations of practical ability normally covered in the 10 curricula of American veterinary colleges. The form of the examination shall be determined by the board. Applicants shall 11 certify on the application that they have read, understood, and 12 13 agree to comply with the laws and rules that the board 14 determines are required for licensure.

15 The requirements imposed by this section shall not be a bar 16 to renewal, reissuance, or restoration of any license issued 17 prior to May 13, 1949.

18 (c) No person shall be registered to practice veterinary 19 technology unless the person:

20 (1) Is eighteen or more years of age;

(a) In every case where it is 2 proposed to refuse to grant, renew, reinstate, or restore a 3 license or registration or to revoke or suspend the exercise of 4 a license or registration for any of the causes enumerated in 5 section 471-10, the person concerned shall be given notice and 6 opportunity for hearing in conformity with chapter 91. 7 (b) In all proceedings before it, the board of veterinary 8 examiners and each member thereof shall have the same powers 9 respecting administering oaths, compelling the attendance of 10 witnesses and the production of documentary evidence, and 11 examining witnesses, as are possessed by circuit courts. In case of disobedience by any person of any order of the board, or 12 13 any member thereof, or of any subpoena issued by it, or the 14 member, or the refusal of any witness to testify to any matter 15 regarding which the witness may lawfully be questioned, any 16 circuit judge, on application by the board, or any member 17 thereof, shall compel obedience as in the case of disobedience 18 of the requirements of a subpoena issued by a circuit court, or 19 a refusal to testify therein."

1 "[+] §471-15[+] Criminal penalties. Any person convicted 2 of violating section 471-2 shall have committed a misdemeanor 3 and be subject to a fine not to exceed \$500 or imprisoned not 4 more than six months, or both. 5 Additionally, all tools, implements, appliances, medicine, 6 and drugs used in the practice of veterinary medicine or 7 veterinary technology by any person convicted of practicing 8 veterinary medicine without a license or veterinary technology 9 without a registration shall be declared forfeited to the State 10 by the court and turned over to the board for disposition as it may choose to make." 11 12 SECTION 10. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored. 13 14 SECTION 11. This Act shall take effect upon its approval. 15

Establishes requirements for the regulation of veterinary technicians and the practice of veterinary technology under chapter 471, Hawaii Revised Statutes, relating to veterinary medicine. Establishes provisions relating to registration requirements, educational requirements, limitations on use of titles, grounds for refusal to grant and revocation or suspension of registration, hearings, and criminal penalties. Requires the board of veterinary examiners to issue certificates of registration to applicants beginning on July 1, 2017.
