A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

T	SECTION 1. The Hawaiian language, the native language of
2	the Native Hawaiian people, was once a thriving language used by
3	Native Hawaiians and foreigners alike. However, by the late

- 4 twentieth century, the Hawaiian language was pushed to the brink
- 5 of extinction due to a number of factors, including an 1896 law
- 6 that banned the speaking of the Hawaiian language in Hawaii
- 7 schools. Fortunately, the Hawaiian language was saved by
- 8 several historic initiatives, including the department of
- $oldsymbol{9}$ education's Hawaiian language immersion program, which was
- 10 launched in the 1980s. The Hawaiian language immersion program,
- 11 ka papahana kaiapuni, is offered at twenty public schools and
- 12 educates more than two thousand students in kindergarten through
- 13 the twelfth grade.
- 14 Federal accountability assessment requirements present a
- 15 challenge for ka papahana kaiapuni. Because English is not
- 16 formally introduced in kaiapuni classrooms until the fifth
- 17 grade, third and fourth grade kaiapuni students have been



- 1 offered assessments in the Hawaiian language in order to comply
- 2 with federal accountability assessment requirements. Beginning
- 3 in the 2005-2006 school year and through the 2010-2011 school
- 4 years, these students were offered the Hawaiian aligned
- 5 portfolio assessment, which was developed in the Hawaiian
- 6 language, specifically for ka papahana kaiapuni. During school
- 7 years 2011-2012 through 2013-2014, English-to-Hawaiian
- 8 translations of the Hawaii state assessment were instead offered
- 9 to third and fourth grade kaiapuni students. These translated
- 10 assessments contained numerous flaws, including inconsistent and
- 11 inaccurate translations, and as a result, failed to accurately
- 12 measure kaiapuni students' academic achievement.
- 13 However, according to board of education policy 2105, "the
- 14 program's effectiveness requires the development and proper
- 15 administration of appropriate formative and summative assessment
- 16 tools. These program evaluation tools should be in alignment
- 17 with the State's kaiapuni curriculum and measure student growth
- 18 and proficiency with the goal to prepare students for success in
- 19 college, career and community."
- 20 The purpose of this Act is to require the department of
- 21 education to develop annual assessments in the Hawaiian language

1	for langu	age arts, mathematics, and science subjects, in
2	accordanc	e with federal accountability assessment requirements,
3	to be adm	inistered to kaiapuni students in certain grades.
4	SECT	ION 2. Section 302H-5, Hawaii Revised Statutes, is
5	amended t	o read as follows:
6	" [4]	§302H-5[+] Student performance[+]; assessments. (a)
7	Beginning	with the 2020-2021 school year, the department of
8	education	shall develop and implement annual assessments in the
9	<u> Hawaiian</u>	language for language arts, mathematics, and science
10	for ka pa	pahana kaiapuni students. The assessments shall:
11	(1)	Be aligned with the vision, mission, and programmatic
12		goals of ka papahana kaiapuni;
13	(2)	Be aligned with applicable state academic content and
14		achievement standards;
15	<u>(3)</u>	Be valid, reliable, and consistent with relevant,
16		nationally-recognized professional and technical
17		standards;
18	(4)	Be compliant with applicable federal accountability
19		assessment requirements; and
20	<u>(5)</u>	Not be Hawaiian translations of the general state
21		assessments.

1	(b) The department of education may develop and use		
2	[multiple] other assessment strategies and instruments to assess		
3	student achievement and performance and to evaluate the		
4	effectiveness of teaching strategies and methods being used in		
5	the Hawaiian language medium education program.		
6	(c) The department, with the assistance of the Hawaiian		
7	language community, including the 'Aha Kauleo Kaiapuni Hawai'i,		
8	members of ka papahana kaiapuni schools, the Hawaiian language		
9	programs at the University of Hawaii at Hilo and University of		
10	Hawaii at Manoa, office of Hawaiian affairs, and other Hawaiian		
11	language community organizations, shall establish procedures for		
12	the development of the assessments specified in this section."		
13	SECTION 3. No later than twenty days prior to the		
14	convening of the regular sessions of 2016 and 2017, the		
15	department of education shall prepare and submit a preliminary		
16	and a final report, respectively, to the legislature on:		
17	(1) The status of the procedures the department is		
18	establishing for the development and administration of		
19	assessments in the Hawaii language pursuant to this		
20	Act;

- (2) The status of waivers sought from the United States
 Department of Education to comply with this Act; and
- 3 (3) Any other actions taken to comply with this Act.
- 4 SECTION 4. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$ or so
- 6 much thereof as may be necessary for fiscal year 2015-2016 and
- 7 the same sum or so much thereof as may be necessary for fiscal
- 8 year 2016-2017 for the development and administration of annual
- 9 assessments in the Hawaiian language as required by section 2 of
- 10 this Act.
- 11 The sums appropriated shall be expended by the department
- 12 of education for the purposes of this Act.
- 13 SECTION 5. Statutory material to be repealed is bracketed
- 14 and stricken. New statutory material is underscored.
- 15 SECTION 6. This Act shall take effect on December 24,
- **16** 2088.
