#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 421I, Hawaii Revised Statutes, is

- 3 and to read as follows:
- 4 "§421I- Adoption of rules; prohibition of smoking
- 5 permitted. A corporation may adopt rules to prohibit tenant
- 6 shareholders, guests, and all other persons from smoking,
- 7 including but not limited to electronic cigarettes, in dwelling
- 8 units, common elements, or limited common elements of the
- 9 corporation."
- 10 SECTION 2. Section 514B-105, Hawaii Revised Statutes, is
- 11 amended by amending subsection (b) to read as follows:
- "(b) [Unless otherwise permitted by the declaration,
- 13 bylaws, or this chapter, an] An association may adopt rules [and
- 14 regulations that affect the use of or behavior in units that
- 15 may be used for residential purposes only to:
- 16 (1) Prevent any use of a unit [which] that violates the
- declaration or bylaws;
