BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 329, Hawaii Revised Statutes, is
2	amended by adding two new sections to be appropriately
3	designated and to read as follows:
4	"§329-A Narcotics advisory committee; established. (a)
5	There is established a narcotics advisory committee within the
6	department for administrative purposes. The committee shall be
7	composed of five members appointed by the governor in accordance
8	with section 26-34. Of the five members:
9	(1) Four members shall be physicians licensed to prescribe
10	prescription drugs within the scope of the physician's
11	practice in accordance with chapter 453; and
12	(2) One member shall be a registered pharmacist, as
13	defined in section 461-1;
14	provided that all members shall be in good standing.
15	(b) All members shall serve a term of years. Any
16,	vacancies occurring in the membership of the committee shall be

- manner as the original appointments. 2
- (c) The purpose of the narcotics advisory committee shall 3
- be to recommend acceptable continuing medical education program 4

- §329-B Continuing medical education program; prescribing 9

- (b) A prescribing practitioner shall earn four credits 14
