BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 302A-121, Hawaii Revised Statutes, is
2	amended to	o read as follows:

4	military	representatives. (a) The board shall consist of

6	(1)	One member from the county of Hawaii;
7	(2)	One member from the county of Maui;

9	(4)	Three members from the city and county of Honolulu;

11	<u>(5)</u>	One member who is a Hawaii public high school student;

13	[(5)]	(6) Three at-large members; provided that the
14		governor shall select an at-large member as the

16	[The] <u>Exc</u>	ept as provided by section 302A-447, members shall be
17	appointed	by the governor, with the advice and consent of the

- 1 senate. The governor may remove or suspend for cause any member
- 2 of the board.
- 3 (b) Pursuant to article XVIII, section 12, of the Hawaii
- 4 State Constitution, the period of transition from the elected to
- 5 the appointed board shall be as determined in section 21 of Act
- 6 5, Session Laws of Hawaii 2011.
- 7 (c) The members of the board shall serve without pay but
- 8 shall be entitled to reimbursement for necessary expenses,
- 9 including travel and board and lodging expenses, while attending
- 10 meetings of the board or when actually engaged in business
- 11 relating to the work of the board.
- 12 [(d) Pursuant to section 302A 447, the state student
- 13 council shall select a nonvoting public high school student
- 14 representative to the board.
- (e) (d) Pursuant to section 302A-1101(c), the board shall
- 16 invite the senior military commander in Hawaii to appoint a
- 17 nonvoting military representative to the board."
- 18 SECTION 2. Section 302A-123, Hawaii Revised Statutes, is
- 19 amended by amending subsection (c) to read as follows:
- "(c) The term of the student [representative] member shall
- 21 be one year. The student [representative] member may be



- 1 selected for one additional consecutive term; provided that the
- 2 student [representative] member shall be a student at the time
- 3 of selection and shall be a student for the majority of that
- 4 term."
- 5 SECTION 3. Section 302A-447, Hawaii Revised Statutes, is
- 6 amended by amending subsection (b) to read as follows:
- 7 "(b) The council shall compile a list of five nominees
- 8 from which the governor shall appoint, with the advice and
- 9 consent of the Senate, the student member to the board. The
- 10 council shall determine whether it shall directly select the
- 11 nominees for student [representative] member to the board or
- 12 whether it shall run an election to select [that individual.]
- 13 the nominees."
- 14 SECTION 4. Upon the expiration of the term of the student
- 15 representative serving on the board of education on the
- 16 effective date of this Act, the governor shall select a student
- 17 member to serve on the board of education pursuant to this Act.
- 18 SECTION 5. Statutory material to be repealed is bracketed
- 19 and stricken. New statutory material is underscored.
