### A BILL FOR AN ACT

RELATING TO FACILITIES FUNDING FOR CHARTER SCHOOLS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that facilities funding
- 2 has been a long-standing issue for charter schools nationally
- 3 and locally. In Hawaii, start-up charter schools have paid the
- 4 costs of their facilities from operational funds. However, Act
- 5 159, Session Laws of Hawaii 2013, authorized the state public
- 6 charter school commission to request facilities funding as part
- 7 of its annual budget request to the director of finance
- 8 beginning with the 2014-2015 fiscal year.
- 9 The legislature further finds that the state public charter
- 10 school commission is currently implementing a facilities pilot
- 11 project to provide funds to various charter schools for small-
- 12 scale facilities projects, with funding allocation based, in
- 13 part, on the need and performance of the charter schools. The
- 14 commission has currently allocated \$680,000 of federal impact
- 15 aid to this pilot program.

The purpose of this Act is to appropriate funds to the
