A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 286-41, Hawaii Revised Statutes, is
- 2 amended by amending subsection (c) to read as follows:
- 3 "(c) If the vehicle to be registered is specially
- 4 constructed[, reconstructed,] or rebuilt; is a special interest
- 5 vehicle; or is an imported vehicle, this fact shall be stated in
- 6 the application and upon the registration of the special
- 7 interest motor vehicle and imported motor vehicle, which has
- 8 been registered until that time in any other state or county,
- 9 and the owner shall surrender to the director of finance the
- 10 certificates of registration or other evidence of such form of
- 11 registration as may be in the applicant's possession or control.
- 12 The director of finance shall grant full faith and credit to the
- 13 currently valid certificates of title and registration
- 14 describing the vehicle, the ownership thereof, and any liens
- 15 noted thereon, issued by any title state or county in which the
- 16 vehicle was last registered. The acceptance by the director of
- 17 finance of a certificate of title or of registration issued by

- 1 another state or county, as provided in this subsection, in the
- 2 absence of knowledge that the certificate is forged, fraudulent,
- 3 or void, shall be a sufficient determination of the genuineness
- 4 and regularity of the certificate and of the truth of the
- 5 recitals therein, and no liability shall be incurred by any
- 6 officer or employee of the director of finance by reason of so
- 7 accepting the certificate."
- 8 SECTION 2. Section 286-42, Hawaii Revised Statutes, is
- 9 amended as follows:
- 1. By amending subsection (a) to read:
- 11 "(a) The county director of finance shall examine and to
- 12 the best of the director's ability determine the genuineness and
- 13 regularity of every registration and transfer of registration of
- 14 a vehicle pursuant to this part to ensure that every certificate
- 15 issued for a vehicle contains true statements of the ownership
- 16 of the vehicle and to prevent the registration of a vehicle by
- 17 any person not entitled to the vehicle. The director of finance
- 18 may require any applicant to furnish information, in addition to
- 19 that contained in the application, that is necessary to satisfy
- 20 the director of finance of the truth and regularity of the
- 21 application. The director of finance may accept any county

- 1 certificate of title issued for a vehicle as prima facie
- 2 evidence of ownership for registration and transfer of
- 3 registration. The director may issue vehicle identification
- 4 numbers for [reconstructed vehicles,] special interest
- 5 vehicles $[\tau]$ or motorcycles that do not have vehicle
- 6 identification numbers if the director determines that the
- 7 requirements of this section have been met.
- 8 The county director of finance may register a motorcycle
- 9 with an aftermarket motorcycle frame, using the number of the
- 10 frame as issued by the manufacturer of the frame, the vehicle
- 11 identification number on the certification label, or a vehicle
- 12 identification number assigned by the director of finance. A
- 13 bill of sale and Manufacturer's Statement of Origin for the
- 14 frame, engine, and transmission must be presented and retained
- 15 as a part of the permanent county registration records. If a
- 16 Manufacturer's Statement of Origin is not available for the
- 17 engine and transmission due to the use of a used [or
- 18 reconstructed] engine, transmission, or both, then a bill of
- 19 sale or other proof of ownership, satisfactory to the director
- 20 of finance must be presented. Except for motorcycles that are
- 21 built on an aftermarket motorcycle frame $[\tau]$ and special interest

•	venicies, [and reconstructed venicies,] any motor venicie or
2	device that is not certified by the manufacturer to be in
3	compliance with all applicable Federal Motor Vehicle Safety
4	Standards as of the date of [+]manufacture[+] shall not be
5	registered."
6	2. By amending subsection (e) to read:
7	"(e) The county finance director, upon being notified by
8	the designated county department that a vehicle is a special
9	interest vehicle [or that a vehicle has been inspected and
10	approved as a reconstructed vehicle], shall cause that fact to
11	be shown upon the registration and title certificates for that
12	vehicle."
13	SECTION 3. Section 286-2, Hawaii Revised Statutes, is
14	amended by deleting the definition of "reconstructed vehicle".
15	[""Reconstructed vehicle" means a vehicle that is
16	registered to be operated on a public highway, and that is:
17	(1) Assembled from new or used parts by a person other
18	than a recognized manufacturer of new vehicles;
19	(2) Modified to the extent that the identity of the
20	vehicle's make, model, or type is obscured by material
21	changes in its appearance; or

1	(3) Modified by the removal, addition, alteration, or
2	substitution of other than original replacement
3	essential parts, including the vehicle's body, power
4	train, steering system, suspension system, exhaust
5	system, intake system, or bumper system;
6	excluding ordinary body repair that does not change the exterior
7	structure of the vehicle. The term does not include a special
8	interest vehicle or a motorcycle."]
9	SECTION 4. Section 286-85, Hawaii Revised Statutes, is
10	repealed.
11	["§286-85 Reconstructed vehicles, approval required. (a)
12	No person shall operate a reconstructed vehicle upon a public
13	highway unless it has been inspected and certified by the
14	designated county agency as meeting the specifications and
15	requirements established in rules and regulations adopted by the
16	state director of transportation.
17	(b) This section shall not apply to any vehicle which is
18	subject to the rules and regulations of the public utilities
19	commission governing safety of operation and equipment.
20	(c) Each county through its chief executive officer, shall
21	designate a county department, whose responsibilities shall
