RELATING TO MOTOR VEHICLE NOISE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 291, Hawaii Revised Statutes, is 2 amended by adding a new section to part II to be appropria
- 2 amended by adding a new section to part II to be appropriately
- 3 designated and to read as follows:
- 4 "§291- Prohibited noise; exemptions. (a) No person or
- 5 persons shall play, use, operate, or permit to be played, used,
- 6 or operated, any:
- 7 (1) Radio;
- 8 (2) Tape recorder;
- 9 <u>(3)</u> Cassette player;
- (4) Compact disc player; or
- 11 (5) Other machine or device for reproducing sound,
- if it is located in or on any motor vehicle on a public street,
- 13 highway, or public space and the sound generated is plainly
- 14 audible at a distance of thirty feet from the device producing
- the sound.
- (b) Possession by a person or persons of any of the
- 17 machines or devices enumerated in subsection (a) shall be prima

7		year of the first offense.	
8	<u>(f)</u>	As used in this section, "plainly audible" means any	
9	sound that can be detected by a person using unaided hearing
