A BILL FOR AN ACT

RELATING TO TRAFFIC VIOLATION RECORDS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that moving violations 2 resulting in a dismissal with prejudice or a not guilty judgment 3 which occurred more than ten years prior to the date of a request for a certified traffic abstract, should not be included 4 5 in the traffic abstract, except for commercial driver licensing traffic records. The legislature further finds that the lapsing 6 7 of a record after a period of ten years for cases in which the accused driver has been exonerated by dismissal with prejudice 8 9 or a not guilty judgment is reasonable and will still serve the intended purposes of including such records on a driver's 10 11 abstract.

12 The purpose of this Act is to exclude from a certified 13 abstract traffic violations record certain alleged violations 14 that have not resulted in a conviction.

15 SECTION 2. Section 287-3, Hawaii Revised Statutes, is 16 amended to read as follows:

4	certified abstract of the bureaus' record, if any, of any person

7	vehicle and any administrative license revocation pursuant to			
8	chapter 291E, part III and chapter 286, part XIV, as it was in

10	bureaus may collect a fee, not to exceed \$20, of which \$18 shall			
11	be deposited into the general fund and \$2 shall be deposited			
12	into the judiciary computer system special fund.			
13	(b) Notwithstanding any provision to the contrary, all			
14	alleged moving violations as well as any convictions resulting			
15	therefrom or any administrative license suspension pursuant to			
16	chapter 291A shall not be included in a certified abstract of			
17	the bureaus' record.			
18	(c) Notwithstanding any provision to the contrary,			
19	beginning on December 1, 2015, all alleged moving violations for			
20	which the disposition of the violation was "dismissed with			
21	prejudice" or "not guilty" which occurred more than ten years

1	prior to the date of the request for the abstract, shall not be			
2	included in a certified abstract of the bureaus' record;			
3	provided that this subsection shall not apply to a certified			
4	abstract of a commercial driver licensed pursuant to part XIII,			
5	chapter 286.			
6	(d) Information relating to all alleged moving violations			
7	for which the disposition of the violation was "dismissed with			
8	prejudice" or "not guilty" which occurred more than ten years			
9	prior to the date of the request for the abstract, shall be			
10	confidential; provided that information relating to all alleged			
11	moving violations of a commercial driver licensed pursuant to			
12	part XIII, chapter 286, shall not be confidential.			
13	(e) The traffic violations bureaus of the district courts			
14	shall not grant any person access to the traffic violation			
15	record of any person, in any form, including an electronic			
16	traffic violation record available through a website approved by			
17	the State of Hawaii, unless the person requesting the			
18	information provides a government issued identification of the			
19	person for whom the traffic violation record is sought.
