### A BILL FOR AN ACT

RELATING TO EDUCATION.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the Reinventing
- 2 Education Act of 2004 (Act 51, Session Laws of Hawaii 2004)
- 3 established a weighted student formula to allocate moneys to
- 4 schools according to the different costs of educating students
- 5 with different needs. Despite the intended equitable
- 6 distribution of funds, the legislature finds that the weighted
- 7 student formula has placed small, remote schools at a
- 8 disadvantage. In the case of Hana high and elementary school,
- 9 the budgetary shortfall has resulted in the loss of several
- 10 well-qualified teachers and has threatened the school's ability
- 11 to offer minimum course requirements for students to earn high
- 12 school diplomas. If Hāna high school is unable to offer its
- 13 students the requisite courses for graduation, those students
- 14 will have to endure a nearly forty-mile, two-hour drive away, to
- 15 the next closest public high school, King Kekaulike high school.
- 16 The legislature finds that despite the current economic
- 17 situation, remote schools should be funded to retain the minimal





- 1 personnel and resources necessary to graduate students. As of
- 2 2005, six schools were excepted from weighted student formula
- 3 allocations, receiving instead categorical allotments that
- 4 guarantee the minimum number of positions and amount of
- 5 resources to ensure that school operations can continue.
- 6 The purpose of this Act is to require:
- 7 (1) That funding allocations for remote schools be 8 determined by categorical allotments rather than the
- 9 weighted student formula; and
- 10 (2) Hāna high and elementary school on Maui to have a 11 minimum number of teachers who do not share support
- staff roles. 12
- 13 SECTION 2. Section 302A-1303.6, Hawaii Revised Statutes,
- 14 is amended to read as follows:
- 15 "§302A-1303.6 Weighted student formula. (a) Based upon
- 16 recommendations from the committee on weights, the board of
- 17 education may adopt a weighted student formula for the
- 18 allocation of moneys to public schools that takes into account
- 19 the educational needs of each student. The department, upon the
- 20 receipt of appropriated moneys, shall use the weighted student
- formula to allocate funds to public schools. Principals shall 21



- 1 expend moneys provided to the principals' schools. This section
- 2 shall only apply to charter schools for fiscal years in which
- 3 the charter schools elect pursuant to section 302D-29 to receive
- 4 allocations according to the procedures and methodology used to
- 5 calculate the weighted student formula allocation.
- 6 (b) For purposes of subsection (a), a remote school, as
- 7 defined in subsection (c), and other schools designated by the
- 8 committee on weights shall not be allocated operating funds
- 9 using the weighted student formula and shall instead be
- 10 allocated operating funds by categorical allotments that
- 11 quarantee the funding of a minimum number of instructional and
- 12 support staff positions to ensure that at least minimum course
- 13 requirements are maintained; provided that:
- 14 Instructional positions shall not be combined with (1)
- 15 support staff positions; and
- (2) 16 There shall be a minimum of two elementary schools per
- 17 elementary grade level.
- 18 (c) For purposes of this section, "remote school" means
- 19 any public school, as defined in section 302A-101, except
- 20 charter schools governed by chapter 302D, that is a high school:

1	(1) Located at least a one-hour drive away from the next
2	nearest public high school; or
3	(2) Located on the island of Lanai, Molokai, or Niihau;
4	provided that if a high school is combined with an elementary,
5	middle, intermediate, or other lower level of schooling, that
6	entire school shall be deemed a high school for the purposes of
7	this subsection."
8	SECTION 3. For purposes of this Act, Hāna high and
9	elementary school shall have:
10	(1) A minimum of five middle school classroom teachers;
11	(2) A minimum of five middle school teachers;
12	(3) A minimum of five high school classroom teachers;
13	(4) Two reading non-classroom teachers; and
14	(5) An induction and mentoring non-classroom teacher.
15	SECTION 4. New statutory material is underscored.
16	SECTION 5. This Act shall take effect on July 1, 2015.

#### Report Title:

Weighted Student Formula; Exception; Remote Schools; Hāna High and Elementary School

#### Description:

Requires remote schools to be allocated funds using categorical allotments, rather than through the weighted student formula. Defines a remote school as any public school that is a high school located at least a one-hour drive away from the next nearest high school or a high school located on the island of Lana'i, Moloka'i, or Ni'ihau. Specifies minimum number of teachers for Hāna high and elementary school.
