A BILL FOR AN ACT

RELATING TO LATEX.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that latex allergy is a
- 2 serious concern because it causes reactions ranging from mild
- 3 rashes to difficulty breathing and deadly anaphylaxis.
- 4 Approximately 3,000,000 people in the general population of the
- 5 United States have this allergy, and incidence is even higher in
- 6 certain at-risk populations. Nearly sixty-eight per cent of
- 7 children with spina bifida and nearly seventeen per cent of
- 8 health care workers have a latex allergy. Individuals with this
- 9 allergy must be vigilant about latex exposure as research has
- 10 shown that latex proteins that cause allergic reactions can be
- 11 transferred from natural rubber latex gloves to food.
- 12 SECTION 2. Chapter 321, Hawaii Revised Statutes, is
- 13 amended by adding a new section to part I to be appropriately
- 14 designated and to read as follows:
- 15 "§321- Dental health facilities; health care facilities;
- 16 use of latex gloves prohibited. The use of latex gloves in
- 17 dental health facilities and health care facilities, including

- 1 all facilities listed in section 321-11(10), shall be
- 2 prohibited; provided that procedures performed in hospital
- 3 operating rooms that adhere to hospital policies and procedures
- 4 that set standards for latex-safe environments shall be
- 5 excluded."
- 6 SECTION 3. Chapter 321, Hawaii Revised Statutes, is
- 7 amended by adding a new section to part XVIII to be
- 8 appropriately designated and to read as follows:
- 9 "§321- Emergency medical services; use of latex gloves
- 10 prohibited. The use of latex gloves by personnel providing
- 11 ambulance services or emergency medical services pursuant to
- 12 this part shall be prohibited."
- 13 SECTION 4. Chapter 328, Hawaii Revised Statutes, is
- 14 amended by adding a new section to part I to be appropriately
- 15 designated and to read as follows:
- 16 "§328- Food establishments; use of latex gloves
- 17 prohibited. The use of latex gloves in a food establishment
- 18 permitted under title 11, chapter 12 of the Hawaii
- 19 administrative rules shall be prohibited."
- 20 SECTION 5. New statutory material is underscored.
- 21 SECTION 6. This Act shall take effect on July 1, 2112.
