A BILL FOR AN ACT

RELATING TO MOTOR VEHICLE LICENSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. The legislature finds that the current State
 law allows a person who has attained the age of seventy-one to
 renew a driver's license for a period of eight years; however, a
 person who has attained the age of seventy-two is only permitted
- 5 to renew a driver's license for a two year period. The result
- ${f 6}$ of this law is that one person may renew a license at the age of
- 7 seventy-one and will hold a valid license until the age of
- 8 eighty, which is the first birthday after eight years from date
- 9 of issuance, while another person may renew a license at the age
- $10\,$ of seventy-two and will hold a valid license only until they
- 11 reach the age of seventy-five, which is the first birthday after
- 12 two years from the date of issuance. The legislature finds that
- 13 the current non-graduated driver's license expiration period is
- 14 arbitrary.
- 15 Accordingly, the purpose of this Act is to create a
- 16 graduated system of driver's license renewal for persons of age
- 17 seventy-one or older.

1	SECTION 2. Section 286-106, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"§286-106 Expiration of licenses.
4	(a) Every driver's license issued under this part, except
5	for a provisional license issued under section 286-102.6 which
6	shall expire on the date of the provisional licensee's
7	nineteenth birthday, whether an original issuance or a renewal,
8	shall expire on the first birthday of the licensee occurring not
9	less than eight years after the date of the issuance of the
10	license, unless sooner revoked or suspended; provided that:
11	(1) The license shall expire on the first birthday of
12	the licensee occurring not less than four years after
13	the date of the issuance if, at the time, the licensee
14	is twenty-four years of age or younger;
15	[(2) The license shall expire on the first birthday of
16	the licensee occurring not less than two years after
17	the date of the issuance of the license if, at that
18	time, the licensee is seventy-two years of age or
19	older; and]
20	(2) Any license issued to a person who is seventy-one
21	years of age or older, at the time, shall expire on
22	the licensee's seventy-ninth birthday, or two years
