### A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR THE ADULT PROTECTIVE AND COMMUNITY SERVICES BRANCH.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$28,183 or so much
- 3 thereof as may be necessary for fiscal year 2015-2016 and the
- 4 sum of \$51,930 or so much thereof as may be necessary for fiscal
- 5 year 2016-2017 to fund two full-time equivalent permanent
- 6 child/adult protective services specialist positions (2.0 FTE)
- 7 to investigate reports of vulnerable adult abuse or neglect in
- 8 the adult protective and community services branch, Oahu
- 9 section, adult protective services units.
- 10 The sums appropriated shall be expended by the department
- of human services for the purposes of this Act.
- 12 SECTION 2. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$14,002 or so much
- 14 thereof as may be necessary for fiscal year 2015-2016 and the
- 15 sum of \$23,070 or so much thereof as may be necessary for fiscal
- 16 year 2016-2017 to fund one full-time equivalent permanent

- 19 thereof as may be necessary for fiscal year 2015-2016 and the
- 20 sum of \$34,605 or so much thereof as may be necessary for fiscal
- 21 year 2016-2017 to fund one full-time equivalent permanent
