A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR THE ADULT PROTECTIVE AND COMMUNITY SERVICES BRANCH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. There is appropriated out of the general
- 2 revenues of the State of Hawaii the sum of \$28,183 or so much
- 3 thereof as may be necessary for fiscal year 2015-2016 and the
- 4 sum of \$51,930 or so much thereof as may be necessary for fiscal
- 5 year 2016-2017 to fund two full-time equivalent (2.0 FTE)
- 6 permanent child/adult protective services specialist positions
- 7 to investigate reports of vulnerable adult abuse or neglect in
- 8 the adult protective and community services branch, Oahu
- 9 section, adult protective services program.
- 10 The sums appropriated shall be expended by the department
- 11 of human services for the purposes of this Act.
- 12 SECTION 2. There is appropriated out of the general
- 13 revenues of the State of Hawaii the sum of \$14,002 or so much
- 14 thereof as may be necessary for fiscal year 2015-2016 and the
- 15 sum of \$23,070 or so much thereof as may be necessary for fiscal
- 16 year 2016-2017 to fund one full-time equivalent (1.0 FTE)
- 17 permanent general professional III position to provide financial



- 1 review, analysis, and support for the adult protective and
- 2 community services branch, Oahu section, adult protective
- 3 services program.
- 4 The sums appropriated shall be expended by the department
- 5 of human services for the purposes of this Act.
- 6 SECTION 3. There is appropriated out of the general
- 7 revenues of the State of Hawaii the sum of \$30,283 or so much
- 8 thereof as may be necessary for fiscal year 2015-2016 and the
- 9 sum of \$56,202 or so much thereof as may be necessary for fiscal
- 10 year 2016-2017 to fund two full-time equivalent (2.0 FTE)
- 11 permanent assistant program administrator V positions to provide
- 12 support for the adult protective and community services branch,
- 13 program development office, adult protective services program.
- 14 The sums appropriated shall be expended by the department
- 15 of human services for the purposes of this Act.
- 16 SECTION 4. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$42,274 or so much
- 18 hereof as may be necessary for fiscal year 2015-2016 and the sum
- 19 of \$77,895 or so much thereof as may be necessary for fiscal
- 20 year 2016-2017 to fund three full-time equivalent (3.0 FTE)
- 21 permanent child/adult protective services specialist positions

- 1 for the Oahu adult intake unit, to provide statewide intake
- 2 functions to the adult protective and community services branch.
- 3 The sums appropriated shall be expended by the department
- 4 of human services for the purposes of this Act.
- 5 SECTION 5. There is appropriated out of the general
- 6 revenues of the State of Hawaii the sum of \$49,379 or so much
- 7 thereof as may be necessary for fiscal year 2015-2016 and the
- 8 sum of \$98,094 or so much thereof as may be necessary for fiscal
- 9 year 2016-2017 to fund two full-time equivalent (2.0 FTE)
- 10 permanent registered nurse IV positions to provide nursing
- 11 support for adult protective services investigations in the
- 12 adult protective and community services branch, West Hawaii
- 13 section and Kauai section.
- 14 The sums appropriated shall be expended by the department
- 15 of human services for the purposes of this Act.
- 16 SECTION 6. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$18,338 or so much
- 18 thereof as may be necessary for fiscal year 2015-2016 and the
- 19 sum of \$34,605 or so much thereof as may be necessary for fiscal
- 20 year 2016-2017 to fund one full-time equivalent (1.0 FTE)
- 21 permanent program specialist III position to provide program

- 1 support in Maui county for the foster grandparent program and
- 2 senior companion program.
- 3 The sums appropriated shall be expended by the department
- 4 of human services for the purposes of this Act.
- 5 SECTION 7. Notwithstanding any law to the contrary, the
- 6 department of human services shall be authorized to extend the
- 7 federal ceiling to fund the positions allocated in this Act and
- 8 to increase the federal money made available for the purposes of
- 9 this Act.
- 10 SECTION 8. This Act shall take effect on July 1, 2015.
