### A BILL FOR AN ACT

RELATING TO THE HAWAII PUBLIC HOUSING AUTHORITY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that affordable housing
- 2 is a serious concern for many Hawaii residents. According to
- 3 the 2011 Hawaii housing planning study, up to fifty thousand new
- 4 housing units will need to be built by 2016 to meet the new
- 5 demand generated by changing demographics and economic
- 6 conditions. Failure to produce sufficient units for low- and
- 7 moderate-income households will cause pent-up demand in these
- 8 market segments.
- The legislature further finds that development of the
- 10 Hawaii public housing authority's North School street location
- 11 will help meet the need for additional public housing and
- 12 administrative services. The development would increase public
- 13 housing inventory by producing approximately three hundred
- 14 housing units and include a new administrative building and a
- 15 small commercial space.
- 16 The purpose of this Act is to create needed housing and
- 17 meet the related administrative demands by appropriating funds

5	SECTION 2. The director of finance is authorized to issue
6	general obligation bonds in the sum of \$10,000,000 or so much
7	thereof as may be necessary and the same sum or so much thereof
8	as may be necessary is appropriated for fiscal year 2015-2016
9	for the redevelopment of the Hawaii public housing authority's
10	administrative offices located on North School street and the
11	design and construction of public housing, affordable rental
12	housing, and commercial space at the same location.
13	SECTION 3. The appropriation made for the capital
14	improvement project authorized by this Act shall not lapse at
15	the end of the fiscal biennium for which the appropriation is
16	made; provided that all moneys from the appropriation

unencumbered as of June 30, 2018, shall lapse as of that date.

SECTION 4. This Act shall take effect on July 1, 2015.
