A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that Act 51, Session Laws
- 2 of Hawaii 2004 (Act 51), sought to revamp education in Hawaii
- 3 by, in part, creating an interagency working group to develop
- 4 plans for transferring certain rights, powers, functions,
- 5 duties, and resources from various state departments to the
- 6 department of education. The interagency working group ceased
- 7 to exist on June 30, 2007.
- 8 The legislature further finds that reestablishing
- 9 interagency working groups will help address various issues that
- 10 either have not been fully resolved since Act 51 or have arisen
- 11 as a result of the transferring of certain rights, powers,
- 12 functions, duties, and resources from the department of
- 13 accounting and general services to the department of education.
- 14 The purpose of this Act is to reestablish an interagency
- 15 working group based on Act 51 with the overall goal of ensuring
- 16 a standard level of service statewide.
- 17 SECTION 2. (a) The department of education shall convene
- 18 an interagency working group to discuss and create a

the department of accounting and general services related to 2 neighbor island public schools to the department of education as 3 previously mandated in Act 51 no later than the 2017-2018 fiscal 4 5 biennium. This plan shall address issues relating to: Necessary statewide capital improvements to public 6 (1)7 school campuses for compliance with section 504 of the Rehabilitation Act of 1973; 8 9 (2) Repair and maintenance of public school facilities on the islands of Hawaii, Maui, Molokai, Lanai, and 10 Kauai; and 11 (3) Any other relevant issues, including but not limited 12 13 to staffing and capacity issues, arising out of section 42 of Act 51, Session Laws of Hawaii 2004, 14 that relate to the department of education and the 15

- 10 (d) The working group shall be dissolved on June 30, 2016.
- 11 SECTION 3. There is appropriated out of the general
- 12 revenues of the State of Hawaii the sum of \$ or so
- 13 much thereof as may be necessary for fiscal year 2015-2016 for
- 14 the department of education to convene the interagency working
- 15 group established pursuant to this Act.
- 16 The sum appropriated shall be expended by the department of
- 17 education for the purposes of this Act.
- 18 SECTION 4. This Act shall take effect on July 1, 2015.
