BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 463-2, Hawaii Revised Statutes, is
- 2 amended to read as follows:
- 3 "\$463-2 Board of private detectives and guards;
- 4 appointment; qualifications; term. Appointment and removal.
- 5 There shall be a board of detectives and guards consisting of
- 6 seven members, six of whom shall be nominated, and by and with
- 7 the advice and consent of the senate, appointed by the governor.
- 8 The terms of the members shall be for four years. Each term
- 9 shall commence on July 1 and expire on June 30. No person shall
- 10 be appointed consecutively to more than two terms, provided that
- 11 membership shall not exceed eight consecutive years. The
- 12 director of commerce and consumer affairs shall be an ex
- officio[+],[+] nonvoting seventh member of the board and may
- 14 designate a representative to sit in the director's stead.

8	SECTION 2. This Act does not affect rights and duties tha
9	matured, penalties that were incurred, and proceedings that wer
10	begun before its effective date.
11	SECTION 3. Statutory material to be repealed is bracketed
12	and stricken. New statutory material is underscored.
13	SECTION 4. This Act shall take effect upon its approval.
