SENATE CONCURRENT RESOLUTION

REQUESTING THE ESTABLISHMENT OF A BONA FIDE AGRICULTURAL PRODUCER TASK FORCE TO CREATE A DEFINITION FOR THE TERM "BONA FIDE AGRICULTURAL PRODUCER".

WHEREAS, Hawaii's local agricultural producers provide fresh and healthy foods and products that benefit the people of Hawaii; and

WHEREAS, the State recognizes the important service that local agricultural producers provide in sustaining Hawaii's quality of life and local economy; and

WHEREAS, the State often assists agricultural producers through legislation and restricts abuse of government programs by limiting assistance to bona fide agricultural producers; and

WHEREAS, creation of a definition for the term "bona fide agricultural producer" is important to ensure the effectiveness of current and future government policies and programs; now, therefore,

BE IT RESOLVED by the Senate of the Twenty-eighth Legislature of the State of Hawaii, Regular Session of 2016, the House of Representatives concurring, that this body is requested to establish a Bona Fide Agricultural Producer Task Force to create a definition for the term "bona fide agricultural producer"; and

BE IT FURTHER RESOLVED that the task force may create a single definition to be used across state government or create different definitions to be applied for different uses; and

BE IT FURTHER RESOLVED that the membership of the task force is requested to include five representatives of farmers and ranchers, with at least one from each county, and one designee of each of the following:
