SENATE CONCURRENT RESOLUTION

ENCOURAGING THE HAWAII TOURISM AUTHORITY AND STATE HISTORIC PRESERVATION DIVISION TO WORK WITH COMMUNITY ORGANIZATIONS TO ASSIST IN THE ESTABLISHMENT OF HISTORICAL MARKERS AND TRAILS.

WHEREAS, one of the principal objectives of cultural heritage tourism is collaboration with local organizations and the public to develop sustainable economies; and

WHEREAS, the Hawaii Tourism Authority recognizes that some visitors' pursuit of a more authentic experience has resulted in increased tourism in Hawaii's small rural communities; and

WHEREAS, increased tourism in rural areas creates jobs and new business opportunities, and strengthens local economies so residents can live, work, and play within their community; and

WHEREAS, historical trails and walking tours have been utilized by community stakeholders to identify historic individuals or landmarks, encourage pedestrian traffic, and improve the local economy; and

WHEREAS, historical trails and walking tours have been created in Waikiki, Haleiwa, and Lahaina to increase cultural heritage tourism; now, therefore,

BE IT RESOLVED by the Senate of the Twenty-eighth Legislature of the State of Hawaii, Regular Session of 2016, the House of Representatives concurring, that the Hawaii Tourism Authority and State Historic Preservation Division of the Department of Land and Natural Resources are encouraged to work with community organizations to assist and support with the establishment of historical markers and trails; and
