
SENATE CONCURRENT RESOLUTION

REQUESTING THE CONVENING OF AN EARLY CHILDHOOD SEXUAL ABUSE
WORKING GROUP TO ADDRESS AND REDUCE CHILD SEXUAL ABUSE IN
HAWAII.

1 WHEREAS, while child sexual abuse statistics vary, most
2 research studies show between seventeen and twenty-five percent
3 of girls and between seven and sixteen percent of boys will
4 experience sexual abuse before the age of eighteen; and

5
6 WHEREAS, the emotional and physical pain suffered in
7 childhood often results in depression, drug addiction, suicide,
8 teenage pregnancy, and juvenile delinquency; and

9
10 WHEREAS, child sexual abuse crosses the boundaries of every
11 economic level and ethnic and religious group; and

12
13 WHEREAS, an early childhood sexual abuse working group
14 should be convened to identify the means of addressing early
15 childhood sexual abuse and create strategies for reducing child
16 sexual abuse in Hawaii; now, therefore,

18 BE IT RESOLVED by the Senate of the Twenty-eighth
19 Legislature of the State of Hawaii, Regular Session of 2016, the
20 House of Representatives concurring, that the Department of
21 Human Services is requested to convene an early childhood sexual
22 abuse working group to identify the means of addressing early
23 childhood sexual abuse and create strategies for reducing child
24 sexual abuse in Hawaii; and

26 BE IT FURTHER RESOLVED that the early childhood sexual
27 abuse working group be composed of the following members: Chair
28 of the Senate Committee on Human Services; Chair of the House
29 Committee on Human Services; Director of Health or the
30 Director's designee; Director of Human Services, or the
31 Director's designee; Superintendent of Education, or the



1 Superintendent's designee; a representative from the Early
2 Intervention Section of the Department of Health; a
3 representative from Prevent Child Abuse Hawaii; representatives
4 of direct service providers; representatives from the preschool
5 community; representatives of health care providers, including
6 pediatricians; and representatives from additional state
7 agencies; and

8
9 BE IT FURTHER RESOLVED that in devising strategies to
10 reduce child sexual abuse, it is requested that the working
11 group:

13 (1) Gather information concerning child sexual abuse
14 throughout the State;
15
16 (2) Hold public meetings to receive or discuss reports and
17 testimony from individuals, state and local agencies,
18 community-based organizations, and other public and
19 private organizations; and

21 (3) Create goals for a state policy that would prevent
22 early childhood sexual abuse and improve detection,
23 identification, and response to early childhood sexual
24 abuse; and

26 BE IT FURTHER RESOLVED that the early childhood sexual
27 abuse working group is requested to report its findings and
28 recommendations to the Legislature no later than twenty days
29 prior to the convening of the Regular Session of 2017; and

31 BE IT FURTHER RESOLVED that certified copies of this
32 Concurrent Resolution be transmitted to the Chair of the Senate
33 Committee on Human Services, Chair of the House Committee on
34 Human Services, Director of Health, Director of Human Services,
35 Superintendent of Education, and Prevent Child Abuse Hawaii.
