begs leave to report as follows:

Your Committee has reviewed the personal history, resume, and
statement submitted by the nominee and finds Scott Ai to possess
the requisite qualifications to be nominated to the Pest Control
Board.

Your Committee received testimony in support of the
nomination of Scott Ai from the Department of Commerce and
Consumer Affairs.

Upon review of the testimony, your Committee finds that
Mr. Ai's background and commitment to public service qualify him
for appointment and reappointment to the Pest Control Board as a
public member. Your Committee notes that Mr. Ai's background is
in construction, where he has worked in a management capacity for
specialty construction companies for more than twenty years and
currently serves as the Vice President of Estimating for Beachside



Roofing, LLC. Mr. Ai has experience with multiple boards by virtue of his service as the past President and current Vice President for the Roofing Contractors Association of Hawaii, serving as a member of various trust fund boards for the Roofer's Union, Local 221, and his current service as President of his association of apartment owners. Your Committee further finds that Mr. Ai has served as an interim member since January 2016 and has a thorough understanding of the role and responsibilities of board members. Your Committee therefore recommends that Mr. Ai be appointed and reappointed to the Pest Control Board based on his knowledge, experience, and dedication to serving his community.

As affirmed by the record of votes of the members of your Committee on Commerce, Consumer Protection, and Health that is attached to this report, your Committee, after full consideration of the background, experience, and qualifications of the nominee, has found the nominee to be qualified for the position to which nominated and recommends that the Senate advise and consent to the nomination.


