Your Committee received testimony in support of the nomination of Michael Stewart from the Department of Health and one individual.

Your Committee finds that Mr. Stewart's professional experience, as well as his background in working with multi-cultural and varied socio-economic groups, will be great assets to the Mental Health and Substance Abuse, Oahu Service Area Board.

#### TRENNA SYKES-HEBERT

Your Committee received testimony in support of the nomination of Trenna Sykes-Hebert from the Department of Health and four individuals.

Your Committee finds that Ms. Sykes-Hebert is presently the Managing Program Director for American Indian and Alaska Native Healthcare in Hawaii and a Case Management Consultant and has previous work experience as a Community Development Block Grant Case Manager with the City and County of Honolulu's Rent to Work Through her experiences, Ms. Sykes-Hebert has Program. demonstrated her ability to advocate for and serve individuals who are homeless, medically fragile, substance abusers, and mentally ill. Ms. Sykes-Hebert has indicated in her personal statement that she has written several resource guides related to affordable housing and substance abuse treatment strategies and is knowledgeable about the various resources that are available to serve those suffering from mental illness and substance abuse. Your Committee finds that Ms. Sykes-Hebert's background in working with Hawaii's most vulnerable populations, as well as her passion for serving the community, will be great assets to the Mental Health and Substance Abuse, Oahu Service Area Board.

As affirmed by the records of votes of the members of your Committee on Commerce, Consumer Protection, and Health that are attached to this report, your Committee, after full consideration of the background, experience, and qualifications of the nominees, has found the nominees to be qualified for the positions to which nominated and recommends that the Senate advise and consent to the nominations.
