### BRANDON MARC HIGA

Your Committee received testimony in support of the nomination for the appointment of Brandon Marc Higa from the Hawaii Government Employees Association, Hawaii Friends of Civil Rights, Kalāualani Native Hawaiian Council, Ashford and Wriston, and eight individuals.

Upon review of the testimony, your Committee finds that Mr. Higa's education, experience, and background qualify him for appointment to the Board of Regents of the University of Hawai'i as a student member. Your Committee notes that Mr. Higa's outstanding work as a Grants Development Specialist at the Kapiolani Community College has earned him praise from his colleagues and peers. Your Committee also notes that the dean of the William S. Richardson School of Law, where Mr. Higa is

Upon review of the testimony, your Committee finds that Ms. Tagorda's experience with the University of Hawai'i as a Student Regent will continue to be an asset to the Board of Regents of the University of Hawai'i when the Board conducts its business and deliberations.
