Your Committee on Finance, to which was referred H.B. No. 1112, H.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO THE HAWAII HEALTH SYSTEMS CORPORATION,"

begs leave to report as follows:

The purpose of this measure is to restructure and facilitate the operations of the Hawaii Health Systems Corporation (HHSC) by, among other things:

- Reconsolidating HHSC operational administration and oversight by eliminating regional system boards and setting new membership guidelines for the HHSC corporation board;
- (2) Repealing certain limitations on operational authority within HHSC, consistent with the consolidated administration; and
- (3) Establishing new voting and approval requirements for HHSC supplemental bargaining agreements for units (1), (2), (3), (4), (9), (10), and (13).

Lanai Community Health Center and several individuals supported this measure. The HHSC West Hawaii Region, HHSC East Hawaii Region, Maui Memorial Medical Center, Hawaii Academy of Family Physicians, HHSC Primary Care Training Program, and
