Your Committee on Ways and Means, to which was referred H.B. No. 1669, H.D. 2, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO PUBLIC ACCOUNTANCY,"

begs leave to report as follows:

The purpose and intent of this measure is to improve peer reviews for public accountancy.

Specifically, this measure:

- (1) Redefines "peer review" to include reviews done by outof-state public accountancy licensees;
- (2) Extends deadlines for filing of peer review compliance reporting forms and for appealing certain ratings from ten days to thirty calendar days;
- (3) Allows members of the public accountancy peer review oversight committee to be reimbursed for expenses and protects members from civil liability for actions done in furtherance of the purposes of the committee;
- (4) Defines the term "Hawaii attest work"; and
- (5) Clarifies that a peer reviewer is required to select one or more engagements from the list of engagements obtained from a reviewed firm.
