"A BILL FOR AN ACT RELATING TO WATER MANAGEMENT,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to amend the goals of the Hawaii water plan to include increased utilization of reclaimed water in all state facilities, where feasible.

Your Committee on Conference has amended this measure by:

- Clarifying that the goal shall be to achieve utilization of reclaimed water for uses other than drinking and for potable water needs in one hundred percent of state and county facilities by December 31, 2045; and
- (2) Making the measure effective upon its approval.
