"A BILL FOR AN ACT RELATING TO SOCIAL WORKERS,"

The purpose of this measure is to clarify the supervision requirements for licensure of clinical social workers, including permitting the supervision requirements to be met through face-toface supervision or via a Health Insurance Portability and Accountability Act of 1996-compliant video conference service.

The National Association of Social Workers, Hawaii Chapter and numerous concerned individuals supported this measure. The Department of Commerce and Consumer Affairs provided comments.

Your Committee has amended this measure by:

- Requiring the supervision of social worker applicants to include the review of assessments;
- (2) Changing the effective date to July 1, 3000, to encourage further discussion; and
- (3) Making technical, nonsubstantive amendments for clarity, consistency, and style.
