Your Committee has amended this measure by changing its effective date to July 1, 2091, to facilitate further discussion.

No. 2204, as amended herein, and recommends that it pass Second Reading in the form attached hereto as H.B. No. 2204, H.D. 1, and be referred to your Committee on Education.
