Your Committee on Finance, to which was referred H.C.R. No. 90 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE CHIEF OF THE DEPARTMENT OF HEALTH EMERGENCY MEDICAL SERVICES AND INJURY PREVENTION SYSTEM BRANCH TO CONVENE AND CHAIR A WORKING GROUP TO DEVELOP A COMMUNITY PARAMEDIC PROGRAM, INCLUDING EDUCATIONAL STANDARDS FOR CERTIFICATIONS, TO ALLEVIATE EMERGENCY SERVICES FROM RESPONDING TO NON-EMERGENCY CALLS,"

The purpose of this measure is to request the Chief of the Department of Health Emergency Medical Services and Injury Prevention System Branch to convene and chair a working group to develop a community paramedic program, including educational standards for certifications, to alleviate emergency services from responding to non-emergency calls.
