to be exempt from minimum wage, overtime, and record keeping
requirements.


Your Committee received testimony in support of this measure
from the Department of Labor and Industrial Relations. Your
Committee received testimony in opposition to this measure from
the Chamber of Commerce Hawaii and Hawaii Food Industry
Association.

Your Committee finds that this is a housekeeping measure that
corrects the inequity of guaranteed compensation remaining at the
same level, while the minimum wage increases as scheduled over the
next three years.

As affirmed by the record of votes of the members of your
Committee on Judiciary and Labor that is attached to this report,
your Committee is in accord with the intent and purpose of S.B.
No. 1122 and recommends that it pass Second Reading and be
referred to the Committee on Ways and Means.
