The purpose and intent of this measure is to:

- (1) Establish a Transit Oriented Development Coordinator position within the Office of Planning; and
- (2) Make an appropriation to establish the Transit Oriented Development Coordinator position.

Your Committees find that the State owns a number of parcels of land along the Oahu rail route and would greatly benefit from having a specialized planner to work with various state agencies who manage lands to coordinate with the Office of Planning.
