Your Committee on Higher Education, to which was referred S.B. No. 2040, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO POST-SECONDARY EDUCATION,"

begs leave to report as follows:

The purpose of this measure is to help the Hawaii Postsecondary Education Authorization Program to carry out its duties more effectively by:

- Specifying that when a private institution of postsecondary education ceases to operate in the State, it must deposit with the Department of Commerce and Consumer Affairs only those educational records that have been requested by the Department;
- (2) Clarifying that when a private institution of postsecondary education ceases to operate in the State, the student transcripts permanently retained by the Department shall be in a form prescribed by the Director of Commerce and Consumer Affairs; and
- (3) Allowing any other records requested and obtained by the Department from a private institution of post-secondary education that has ceased to operate in the State, to be retained for the length of time of prescribed by the Director.
