"A BILL FOR AN ACT RELATING TO ACCESS TO TREATMENT FOR TERMINALLY ILL PATIENTS,"

begs leave to report as follows:

The purpose of this measure is to adopt "Right to Try" legislation that allows terminally ill patients to use and manufacturers to make available potentially life-saving investigational drugs and biological products.

Several concerned individuals testified in support of this measure. The Department of the Attorney General and the Hawaii Association for Justice provided comments.

Your Committee has amended this measure by:

- Clarifying that a health care provider that recommends to an eligible patient an investigational drug or biological product that is being developed to treat the type of terminal illness that afflicts the patient will not serve as a basis for licensing or certification sanctions;
- (2) Making this measure effective upon approval; and
