Your Committee on Economic Development, Environment, and Technology, to which was referred S.B. No. 2506 entitled:

"A BILL FOR AN ACT RELATING TO THE ISSUANCE OF SPECIAL PURPOSE REVENUE BONDS TO ASSIST TRUTAG TECHNOLOGIES, INC,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the issuance of special purpose revenue bonds to assist TruTag Technologies, Inc., as a manufacturing enterprise.

Your Committee received testimony in support of this measure from the Chamber of Commerce of Hawaii; TruTag Technologies, Inc.; and three individuals. Your Committee received comments on this measure from the Department of Budget and Finance.

Your Committee finds that the proceeds of the sale of special purpose revenue bonds will be used by TruTag Technologies, Inc., to finance or refinance the planning, construction, improvement, and equipping of its manufacturing facilities in the State to produce silica microtags for identification, tracking, authentication, brand protection, and quality assurance of highvolume, high-value items, such as electronics and industrial parts. Your Committee further finds that the issuance of these special purpose revenue bonds is in the public interest and will benefit the public health, safety, and general welfare.

As affirmed by the record of votes of the members of your Committee on Economic Development, Environment, and Technology that is attached to this report, your Committee is in accord with
