Your Committee on Conference on the disagreeing vote of the Senate to the amendments proposed by the House of Representatives in S.B. No. 2583, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO COMPOSTING TOILETS,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to mandate the counties to approve the installation and use of composting toilets in areas that are inaccessible to municipal wastewater systems.

Your Committee on Conference finds that Act 187, Session Laws of Hawaii 2015, authorized the counties to approve the installation and use of composting toilets in areas that are inaccessible to municipal wastewater systems. Composting toilets have been proposed as a means to bring toilet facilities to populations without adequate access to sanitation facilities, such as individuals living in areas where geological features or the limits of existing infrastructure make the use of conventional toilets and septic systems impracticable, or homeless individuals living in

encampments. This measure requires counties to approve the installation of composting toilets.

Your Committee on Conference has amended this measure by making it effective upon approval.

No. 2583, H.D. 1, as amended herein, and recommends that it pass Final Reading in the form attached hereto as S.B. No. 2583, H.D. 1, C.D. 1.
