Sir:

Your Committee on Judiciary and Labor, to which was referred S.B. No. 2840, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO REPORTING DEATHS TO STATE AGENCIES,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the Department of Health to continue to disclose, including through electronic means, lists of names of persons whose deaths have been recorded by the Department to state agencies that maintain official lists of persons and are prohibited by federal law from sharing information for the lists.

Your Committee received testimony in support of this measure from the Department of Human Services and Hawaii Employer-Union Health Benefits Trust Fund.

Your Committee finds that although the Department of Health is allowed to verify information contained in vital statistics records by employing a process that matches its vital statistics information with information provided by agencies, that process cannot be used by state agencies whose lists are confidential under federal law. Your Committee further finds that some governmental agencies within the State that keep official lists of persons need to know when members on their lists have died. Such notification of death is important in maintaining the integrity of certain programs, such as Medicaid, by stopping unnecessary payments to contracted managed care health plans on behalf of

deceased individuals. By allowing the Department of Health to report deaths to state agencies that maintain official lists that are confidential under federal law, this measure assists state agencies in maximizing the accuracy of their official lists and avoiding the overpayment of benefits and waste of public funds.

As affirmed by the record of votes of the members of your Committee on Judiciary and Labor that is attached to this report, your Committee is in accord with the intent and purpose of S.B. No. 2840, S.D. 1, and recommends that it pass Third Reading.
