<u>HB-326</u> <u>Status</u>	RELATING TO THE BANK OF THE STATE OF HAWAII. Directs DCCA to conduct a comprehensive review of relevant state laws to develop legislation to establish the bank of the State of Hawaii. Appropriates funds to conduct the review. Directs the HHFDC to establish and operate an interim purchase program for distressed residential properties encumbered by problematic mortgages until the bank of the State of Hawaii is operational. Establishes minimum percentages of state funds that shall be deposited in the bank of the State of Hawaii.	<del>CPC, FIN</del>
HB 1096 Status	RELATING TO THE SECURE AND FAIR ENFORCEMENT FOR MORTGAGE LICENSING ACT. Authorizes mortgage loan originator companies to post, at the company's principal place of business and each branch office, language specifying that members of the public are seen by appointment during posted business hours.	CPC, FIN
HB 33, HD1 (HSCR33) Status	RELATING TO THE RESIDENTIAL LANDLORD-TENANT CODE. Allows a landlord, when processing an application to rent residential property to charge an application screening fee for the actual costs of screening the applicant, plus an additional administrative fee. Requires landlords to refund any unused amount of the application screening fee and provide a copy of any report obtained via the screening process to the applicant. (HB33 HD1)	HSG, CPC, FIN



HB 1463, HD1 Proposed HD2 Status	RELATING TO TRANSPORTATION. Proposed HD2: Adopts the NCOIL model act to regulate transportation network companies and their drivers, by requiring companies to obtain permits to operate from the PUC, requiring companies and their drivers to meet financial responsibility requirements, and allowing motor vehicle insurers to exclude coverage for motor vehicles when in use for transportation network company. <u>HB 1507, HD1</u> ( <u>HSCR406)</u> <u>Status</u>	RELATING TO ENVIRONMENTAL PROTECTION. Establishes a working group to study methods to reduce the use of all disposable bags. (HB1507 HD1)	EEP, CPC
<u>HB 726, HD1</u> Proposed HD2 <u>Status</u>	RELATING TO THE HAWAII HEALTH CONNECTOR. Proposed HD2: Repeals the Hawaii Health Connector. (HB726 HD2 PROPOSED)	HLT, CPC, FIN
