<u>SB 2661, SD1</u> (SSCR2688) Status

### **RELATING TO CONDOMINIUMS.**

Part I: Purpose section. Part II: Clarifies that when a unit owner and association reach a payment plan to cure a nonjudicial foreclosure, completion of the payment plan is required to cure the default; specifies that if a unit owner and an association have agreed on a payment plan to prevent a nonjudicial foreclosure from proceeding, any association fines imposed while the payment plan is in effect shall not be deemed a default under the payment plan; and clarifies the obligations of a unit owner and an association while a unit owner is not otherwise in default under a payment plan. Part III: Clarifies that the pay first, dispute later provisions in Hawaii's condominium law apply only to common expense assessments claimed by an association of apartment owners; specifies that a unit or apartment owner who disputes the amount of an assessment may request a written statement about the assessment from the association, including that a unit or apartment owner may demand mediation prior to paying contested charges, other than common expense assessments; specifies requirements for mediation on contested charges, except for common expense assessments; and repeals language that permitted associations to convert delinquent fines and late fees into delinquent common expense assessments, if certain conditions were met. Part IV: Makes conforming amendments. (SD1)

<u>SB 2619, SD1</u> (SSCR2632) <u>Status</u>	RELATING TO UNCLAIMED PROPERTY. Requires a holder of unclaimed property to provide a statement in its report to the director of finance that the holder has complied with certain requirements, including providing notice to the apparent owner. Requires a holder of unclaimed property valued at \$50 or more to provide notice to the apparent owner via mail, electronic mail, or telephone no more than six months prior to the holder submitting the report to the director of finance. <u>SB 2671, SD1</u> ( <u>SSCR2633)</u> <u>Status</u>	RELATING TO VETERINARY TECHNICIANS. Beginning 7/1/2018, establishes requirements for the regulation of veterinary technicians and the practice of veterinary technology. Establishes registration requirements and limitations on use of titles for veterinary technicians. Appropriates funds to implement the registration of veterinary technicians. (SD1)	CPC, FIN
<u>SB 2298, SD1</u> ( <u>SSCR2558)</u> <u>Status</u>	RELATING TO THE UNIFORM FIDUCIARY ACCESS TO DIGITAL ASSETS ACT. Adopts the Revised Uniform Fiduciary Access to Digital Assets Act, which provides authority to plan for the management and disposition of digital assets. (SD1)	CPC, JUD, FIN
<u>SB 2333, SD1</u> ( <u>SSCR2492)</u> <u>Status</u>	RELATED TO LICENSED MARRIAGE AND FAMILY THERAPISTS. Permits marriage and family therapists licensed pursuant to chapter 451J, Hawaii Revised Statutes, to use the title "licensed marriage and family therapist". Makes conforming amendments. <u>SB 2008, SD1</u> ( <u>SSCR2550)</u> <u>Status</u>	RELATING TO SERVICE AREA BOARDS. Amends statutory provisions relating to quorum and voting requirements for service area boards on mental health and substance abuse. Designates service area boards on mental health and substance abuse within the department of health for administrative purposes. (SD1)	CPC, FIN

<u>SB 2732</u> ( <u>SSCR2506)</u> <u>Status</u>	RELATING TO THE HAWAII HURRICANE RELIEF FUND. Requires the interest earned on the balance of the Hawaii hurricane reserve trust fund to be retained in the trust fund. Requires the board of directors of the Hawaii hurricane relief fund to conduct a study of the acquisition of a catastrophic hurricane loss financing arrangement with all or a portion of the interest earned in the trust fund. Appropriates hurricane reserve trust fund moneys for the study. Effective 07/01/16.	CPC, FIN
