HB 2517 RELATING TO CESSPOOL TAX CREDITS.

Adds cesspools that are within two hundred feet of an existing sewer

system to the definition of "qualified cesspool" for the purposes of determining eligibility for upgrade or conversion tax credits.

RELATING TO CESSPOOLS. EEP/HLT, FIN

EEP/HLT, FIN

Authorizes that department of health to establish a cesspool upgrade, conversion, or connection rebate program. Disallows the tax credit for cesspool upgrade, conversion, or connection for taxpayers whose adjusted gross income exceeds certain amounts. Applies tax credit to all cesspools, regardless of location. Provides that cesspools found to be illegal, as a result of an inspection conducted due to a person applying for a rebate or taxpayer claiming a credit, shall not be subject

to penalty.
